<sup>\*</sup> CONDITIONS.—That the Lessee keep and maintain the ferry over the Clarence River, and provide a properly qualified ferryman, to be approved of by the Government. That the charges for ferrying shall not be more than 2s. 6d. for a man and horse, and 1s. for a foot traveller. That the Lessee shall keep an accommodation house for the use of travellers, to the satisfaction of the Government, but no license for the sale of spirituous liquors will be granted. That the Lessee shall not at any time have more than 300 sheep or 50 head of cattle on the Reserve, except stock travelling through the reserve, for which a charge shall be made as follows:—Horses and cattle, 1s. per head for each night for the first 20 head, and 6d. per head per night for all above that number; and sheep, 2d. each for the first 50 per night, and 1d. each per night for all above that number.
