Auckland Harbour Endowment.

All that portion of Section No. 2 of the City of Auckland, in the Parish of Waitemata, in the County of Eden, containing by admeasurement four acres and three roods (more or less), bounded on the North by Customhouse Street, 1,180 links; on the East, South-east, and South by Fore Street, 216 links, 639 links, and 553 links; and on the West by allotments numbers 1, 2, 3, 4 and 5, of same section No. 2, 510 links.
