II.—LEADING FEATURES OF NEW RULES REGISTERED.

The provisions of "The Friendly Societies Act, 1867," required that the rules of a society could not be registered until the tables of contributions payable for the assurance of sums on sickness or death had been certified to by an actuary or person appointed by the Registrar. No such provision was inserted in "The Friendly Societies Act, 1877," except in cases of deferred annuities, and a registration of rules may now be effected although the contributions may be quite inadequate to pay the promised benefits. It may, therefore, be of interest to note the leading features of the rules registered during the year, so far as they relate to the measure of the contributions provided therein.

Court Queen of the Isles, A.O.F.—The alteration chiefly consisted in an increased and graduated

scale of contributions.
