6. That the preamble has been substantiated by evidence, and that, in the opinion of the Committee, the Bill, as amended, should pass.

#### LAND GRANTS TO DISCHARGED SOLDIERS OF THE IMPERIAL SERVICE.

of land to which they claim to be entitled, the Committee is of opinion,—

1. That the claims of soldiers discharged in the colony should be recognized where at any time the claimants have been entitled to grants of land, but, through informality or ignorance of the regulations, failed to comply with the conditions.

2. That where the bona fides of a claim shall have been established, a grant of sixty (60) acres

of land should be awarded in such manner as the Minister of Lands may determine.

3. That the Government should bring in a Bill to give effect to the foregoing resolutions during the next session of Parliament.
