ASSURANCE FUND UNDER LAND TRANSFER ACT

Return to an Order of the House of Representatives, dated 1st October, 1884.

Ordered, "That there be laid upon the table a return from each provincial district or Land Registrar's district of (1) the amount of money received as contributions to the Assurance Fund under the Land Transfer Act, and how the accumulations of said fund are invested; (2) the amount of claims made on the said fund; (3) the amount of claims paid out of the said fund; (4) the amount of claims refused; (5) the amount of claims settled outside of the department; (6) the amount of claims held over in abeyance."—(Mr. Gillies.)
