E whai honore ana ahau ki te tuku atu inaiane i taku ripoata i runga i te mahi uiui i tu ki Wairau i te marama o Mei o tera tau e pa ana ki te tikanga e rite ana kia meatia tetahi ritenga ano mo etahi whenua mo nga Maori o tera takiwa me te takiwa o Te Hoiere hoki. A e tono ana ahau kia tukua atu tenei ki a Te Kawana.

ME PAI KOE E TE KAWANA,—

I raro i nga ritenga o roto o te Komihana i tukua mai e koe ki au he mea tuhi i te 12 o Mei, 1886, ka karangatia e au nga Maori e noho ana i Wairau i Te Hoiere kia huihui mai ratou ki te pa Maori i Wairau i te 19 o nga ra o taua marama tonu mo enei ritenga ara:—

1. Kia kimihiha nga keehi o nga Maori katoa e kia ana kaore kau o ratou whenua;
2. Kia kimihiha nga keehi e kiai ana, ko nga whenua kua oti te whakarite mo etahi Maori kei te iti rawa, kaore ratou i te noho ora i runga i aua whenua kua whakaritea ra mo ratou;
3. Kia uiuia nga keehi o nga hawhekaiae i Te Waipounamu kaore nei i uru o ratou ingoa ki roto ki etahi Ture o te Paremete a kei te noho kore whenua tonu;
4. Ki te rapu ki te tuhi i nga ingoa me nga nohoanga me te whakaatu hoki he tane, he wahine ranei aua tangata, me te whakarite hoki kia pehea te rahi o te whenua me me te wahi hei takotora-nga e tika ana kia whakataua ki ia tangata o ratou hei mahinga kai hei oranga mo ratou.

I mua i te korerotanga roatanga i te otinga o tenei taku mahi uiui, he mea pai kia korero poto i nga ritenga o te tuatahi mo runga mo te wehewehenga o nga rahui mo aua tangata mo o ratou matua ranei i tu ai tenei uiuinga.
