CIVIL SERVICE APPOINTMENTS

(DETAILS RELATIVE TO).

Return to an Order of the House of Representatives dated 27th June, 1895.

Ordered,—"That a list (1) of all persons who competed for cadetships, and who, though unsuccessful, were appointed to positions in the Civil Service as temporary clerks or otherwise during the years 1892, 1893, and 1894; and (2) of all persons who, without any examination, have been appointed to temporary cadetships, be laid before this House."—(Hon. Sir ROBERT STOUT.)
