Other Lands.—A few small areas have been offered at public competition during the year for occupation for grazing purposes. The Crown lands scheduled in the "Land Guide" for disposal remain practically the same as at the commencement of the year, most of them being lands either of inferior quality or too remote from a market to be capable of profitable occupation on settlement conditions. These lands could, for the most part, only be utilised by owners of adjacent properties, who would probably be debarred from selecting them by the limitations of the Land Act.
