#### ORDER OF REFERENCE.

#### MINERS' RIGHTS FEE REDUCTION BILL.

THE Goldfields and Mines Committee, to whom was referred the Miners' Rights Fee Reduction Bill, have the honour to report that having carefully considered the same they recommend that the Bill be allowed to proceed, with the amendments shown on a copy of the Bill attached hereto. The Committee further express the opinion that, in order to render the reduction of the fee for miners' rights equitable to the North Island, the Government should use every endeavour to acquire all the Native land on the goldfields.

#### No. 81.—Petition of RODERICK MCRAE.

PETITIONER paid £250 and became liable for £750 to satisfy claims for compensation in order to facilitate the proclamation of the Wangapeka River as a watercourse, into which tailings and mining débris might be deposited, such payments and such proclamation being for the public benefit.

The Goldfields and Mines Committee, having taken evidence and carefully weighed the facts set forth in the petition of Roderick McRae, are of opinion that he is equitably entitled to be reimbursed £500. They therefore recommend that petitioner be paid such sum in satisfaction of his claim.

#### No. 230.—Petition of John Ewing, of St. Bathan's, a Mine-owner.

Petitioner represents that he applied for a license to extend his water-race a distance of about six miles, partly through private land; that his application was granted subject to the payment of compensation to the proprietors of the said private land. The Compensation Court, consisting of the Warden and two assessors, by majority, fixed the amount of compensation to be so paid, but when steps were taken to act upon such assessment it was found that the decision could not legally be given effect to, because it was necessary that the Compensation Court should have been unanimous—a condition, under the circumstances, almost impossible of achievement. Petitioner therefore finds himself debarred from the prosecution of his mining enterprise, and prays for relief.

The Goldfields and Mines Committee, having given consideration to the circumstances set forth in the petition of John Ewing, are of opinion that the law requires amendment. The Committee therefore recommend that the said petition be referred to the Government, for the initiation of such legislation as will meet the case of the petitioner, and obviate the occurrence of such

cases in future.

## No. 278.—Petition of John Read.

Petitioner represents that through an erroneous decision given by Mr. Warden Kenny he was constrained to appeal to the Supreme Court, where judgment was given in his favour. He prays that the charges incurred, over and above the costs allowed by the Court, may be refunded to him.

No. 376.—Petition of D. Maloney and 20 Others, of Charleston Riding, Buller County.

## No. 400.—Petition of MARY ANN STITT, of Westport.

Petitioner prays that compensation be allowed to her for serious damage to her property, caused—and likely to continue to be caused—through the proclamation of Bradshaw's Creek as a sludge-channel.

The Goldfields and Mines Committee, having carefully considered the facts embodied in this petition and reported upon the same in 1896, have the honour to report that they have now no recommendation to make.

## No. 472.—Petition of Charles Lewis, a Surveyor, Westport.

Petitioner represents that he was engaged by the Survey Department in 1896 to survey certain gold-mining properties in Mohikinui, West Coast District, the remuneration for his work being fixed by a scale of charges under an Order in Council; that the work having been performed under a second scale of charges, and ignoring the scale under which he had been engaged, the Warden at Westport reduced the amount of the payments due to him, whereby he became a loser to the extent of about £150. He seeks relief.

The Goldfields and Mines Committee having inquired into the statements set forth in the petition of Charles Lewis and considered the same, have the honour to report that they recommend that he be paid the sum of £100 in full settlement of his claims, and that the petition be referred to the Government.

## No. 265.—Petition of ROBERT SHEPHERD, of Charleston.

PETITIONER prays that a sum of £300, lodged by the late J. J. Moynihan on behalf of himself and others as a deposit in connection with an application for a lease of a block of land required for coal-mining purposes, may be returned to him as executor in Moynihan's estate.

The Goldfields and Mines Committee, having carefully considered the questions raised in the petition of Robert Shepherd, have the honour to report that they recommend leave be given to the petitioner to sue the Crown for the purpose of enabling him to establish his claim to the amount referred to in his petition.
