THURSDAY, THE 11TH DAY OF JULY, 1940.

Ordered, "That a Select Committee be appointed, consisting of ten members, to consider all Bills and other matters relating to mining which may be referred to it: the Committee to consist of Mr. Barclay, Mr. Bodkin, Mr. Denham, Mr. Goosman, Mr. Frost, Hon. Mr. Lee Martin. Mr. Moneur, Mr. O'Brien, Mr. Thorn, and the Mover."—(Right Hon. Mr. Fraser, for Hon. Mr. Webb.)

Ordered, "That all petitions not finally dealt with during the session of 1939 be again referred to the same Committees as they were referred to during the said session." (Right Hon. Mr. Fraswn.)

Ordered, "That during the present session all Select Committees appointed by the House have leave to sit on days on which the House is not sitting, provided that when it is proposed to sit on any such day at least three days' notice shall be given to each member of the Committee of the date of the sitting."—(Right Hon, Mr. Fraser.)

WEDNESDAY, THE 28TH DAY OF AUGUST, 1940.

Ordered, "That the Statutes Amendment Bill be referred to the Goldfields and Mines Committee in order to consider clauses 6, 31 to 37 inclusive, and 57 (relating to coal-mines, mining, and Westland and Nelson Coalfields Administration)."—(Right Hon. Mr. Fraser.)

Ordered, "That the Goldfields and Mines Committee have leave to sit during the present sitting of the House."—(Mr. O'BRIEN.)
