No. 73.—Petition of EVA M. CHILLINGWORTH, of Christchurch

PRAYING for investigation of the circumstances of, and compensation for, the termination of her employment by the Canterbury Education Board.

I have the honour to report that the Education Committee has carefully considered this petition, and, regarding sections 1, 2, 4, 5, and 6 in paragraph 44 of the petition, it has no recommendation to make.

Regarding section 3, the Committee recommends that the question of granting petitioner a retiring-allowance be referred to the Government for favourable consideration, and that, in view of petitioner's many years of faithful service as a teacher, she should be permitted to retire on superannuation, and the Government grant her a compassionate allowance which will increase her superannuation to a sum not less than the age-benefit under the Social Security Act.
