## No. 51—Petition of H. E. BROWN

PRAYING for reconsideration of his application for relief under section 17 of the Land and Income Tax Amendment Act, 1945.

I have the honour to report that the Committee has carefully considered the petition, and recommends that it be referred to the Government for favourable consideration, and that the principles and practice of farm accountancy in connection with live-stock values be further investigated in order to establish greater equity in the procedures laid down by the Commissioner of Taxes and that special consideration be given to fixing standard values based on the average market price over a period of years.

## No. 60—Petition of W. G. ANNEAR and OTHERS

PRAYING for the release of bran and pollard to 'poultry-keepers for use in lieu of the standard mash.

I have the honour to report that the Committee has carefully considered the petition, and recommends that until such time as bran and pollard can be made freely available the petition be referred to the Government for the purpose of investigation into the possibility of producing a better balanced poultry mash to meet the need of the poultry-keepers.
