Privilege tickets : Regulation amended.

Judges proceeding to shows : Certificate amended.

Religious bodies : Regulations and certificate amended.

Maoris attending Native Land Courts : Regulation providing for issue of return tickets at single fares inserted.

Trains, special and excursion : Regulations amended—Railway Department reserves right to load up to full capacity without rebating any charges.

LOCAL FARES AND REGULATIONS.

Kawakawa Section.

Passenger-fares amended.

Auckland Section.

Round-trip tickets : Fares for trips Auckland to Auckland *via* Rotorua and Thames ; Auckland to Auckland *via* Hangitiki, Rotorua, and Thames inserted.

Picton Section.

Through booking : Fares and regulations for through journey by rail and steamer between Wellington and Blenheim inserted.

Hurunui-Bluff Section.

Taieri Beach excursions : Regulations amended.

PART II.—LUGGAGE, PARCELS, HORSES, ETC.

Passengers' luggage : Regulations amended—check luggage system adopted, storage charges reduced, size and weight of packages limited.

Bicycle-crates : Regulation amended—rates inserted.

Left luggage : Checked luggage granted twelve hours' free storage.

Type for newspapers for reproduction purposes : Rates reduced.

Horses : Rate for stallions on circuit reduced ; regulations amended.

Stud stock for breeding purposes : Rates reduced.

Homing-pigeons from fanciers' clubs : Rates reduced.

Auckland Section.

Rates and regulations for through booking to Kaipara ports amended.

Wellington-Napier-New Plymouth Section.

Cream rates, Marton to Waverley, reduced.

PART III.—GOODS : CLASSIFIED RATES.

Class E, agricultural produce : Rates reduced.

Small lots : Rates for packages under 1 cwt. reduced.

PART III.—GOODS : REGULATIONS.

Class E : Regulations *re* small lots of agricultural produce amended.

Class F : Regulations *re* lots under 4 tons amended, and rates reduced. Regulation *re* overloading trucks amended.

Class K : Regulations amended—charge for check wagons reduced ; rate for small lots of Australian timber amended, for New Zealand timber not over 6 ft. in length reduced, and for bogie check wagons inserted.

Class M : Rates for stud stock for breeding purposes reduced.

Class P : Regulations amended—rates for manures reduced.

Class Q : Regulations amended—rates for bones reduced.

Seeds for cleaning : Regulation amended, and made applicable only to seeds grown by and to be used by farmers.

Show stock, &c. : Regulations amended, and collie dogs attending dog trials included.

Threshing machinery, &c. : Regulation amended to include sheep-shearing machines.

Tarpaulins : Regulations amended—rates reduced.

Storage : Regulation amended—Wanganui and Wellington included as head stations.

Weighing : Rate for onions inserted.

Returned empties : Rates for empty returned fish-boxes, casks, and sacks reduced ; regulation inserted.

Rates and regulations amended.

Whangarei Section.

A, B, C, D, and H goods, Opau to Kamo : Minimum charge reduced.

Timber : Rates from Foote's siding inserted, and from Waiotu to Opau reduced ; regulation for timber, Mander and Bradley's siding to Opau, inserted, and rates reduced.
