KING-COUNTRY NATIVE LANDS

(PARTICULARS RELATIVE TO) LEASED OR DISPOSED OF DURING LAST FIVE YEARS.

Return to an Order of the House of Representatives dated the 8th October, 1909.

Ordered, "That there be laid before this House a return showing the Native land leased or otherwise disposed of during the last five years in the King-country, giving the particulars of the areas leased and sold, the names of the lessees and purchasers, and the payments or rentals agreed upon; also a summary of the sawmilling-rights agreed upon, and the terms and conditions upon which the timber has been sold."—(Mr. Hogg.)
