NOTE.—Of those summarily convicted 3,455 men and 432 women were dismissed with cautions, without being sentenced to imprisonment; and 83 men and 7 women were released under "The First Offenders Probation Act, 1886." The number of offences (included in the table) charged against persons of the Native race was 501: of the persons so charged, 377 were summarily convicted, 28 committed for trial or sentence, and 96 dismissed.
