Brown and Loudon on the Walton Park line, at the I m. 70 ch. point, and that in addition the sum of £500 be paid in full compensation for all claims in connection with the closing of the old siding, and in full settlement for the closing of the crossing on the main line.

I am directed to report,-

Clause 1. That in the opinion of this Committee the Amalgamated Society of Railway Servants has represented the engine-drivers, firemen, and cleaners equally as well as the other sections of the Railway service.

Clause 2. That due prominence has always been given to the requirements of the enginedrivers, firemen, and cleaners when the Railway Department has been approached by the delegates

of the Amalgamated Society of Railway Servants.

Clause 3 That, notwithstanding this, and after hearing the evidence from both sides and carefully considering it, the Committee is of opinion that there is no possibility of the Amalgamated Society of Railway Servants and the Engine-drivers, Firemen, and Cleaners' Association coming to an agreement, and that, as it is in the best interests of the Railway service that these two sections should work in harmony, this Committee recommends the petition of the Enginedrivers, Firemen, and Cleaners' Association to the Government for favourable consideration.
