ANNUAL REPORTS OF DOMAIN BOARDS.

The Under-Secretary for Lands to the Right Hon. the Minister of Lands.

Department of Lands, Wellington, 24th July, 1911.

I have the honour to transmit herewith a synopsis of the annual reports of Domain Boards for the year ended 31st December, 1910, which have been furnished in accordance with section 45 of the Public Reserves and Domains Act, 1908.

The reports, as in previous years, indicate steady improvement of the public domains of the Dominion.

Some delay in the receipt of reports has been occasioned by a number of Domain. Boards being under the impression that by forwarding a copy of the annual report and balance-sheet to the Audit Department the provisions of the Act have been complied with, overlooking the fact that a copy should also be sent to the Minister of Lands.

AUCKLAND LAND DISTRICT.

AHIRAU DOMAIN.

Section No. 17, Block V, Harataunga Survey District. Area, 16 acres 2 roods.

This domain is under the control of the Commissioner of Crown Lands, Auckland, and is leased on a year-to-year tenancy. Improvements now on domain: Fencing. Used for grazing. Proposed operations for ensuing year: Keeping down noxious weeds

ARATAPU DOMAIN.

Section No. 42, Kopuru Parish. Area, 44 acres 1 rood 35 perches.

Work done during year: Pipe-drains cleaned. Improvements now on domain: Draining and grassing. Leased. Proposed operations for ensuing year: Clearing and planting.

ARAWA PARK DOMAIN.

Section No. 23, Rotorua Rural Sections. Area, 46 acres 3 roods 17 perches.

Work done during year: Domain securely fenced, new gates erected, part ploughed preparatory to sowing in grass, areas set apart for racing-track and football-grounds, and notices placed in conspicuous places. Improvements now on domain: Fencing, trees, and grandstand. Used for races, football, and sports. Proposed operations for ensuing year: Removing present grandstand and replacing it by a new structure, if funds are available.

AUCKLAND DOMAIN.

Situated in Rangitoto Survey District. Area, 236 acres 1 rood.

Work done during year: Eight tennis-courts completed, with small dressing-shed, and bushhouse finished and stocked with plants. Improvements now on domain: Drive, paths, four rustic bridges, fencing, seats, lodge and one other residence, two ponds or lakes concreted at bottom and surrounded with rockery and plantation and fenced with rustic oak, caretaker's residence, three propagating-houses, potting-shed, tool-sheds and boiler-house, bush-house, propagating-frames, nursery and well laid-out grounds and garden, gates, cricket-ground, pavilion, dressing-rooms, conveniences, stabling, and palings. Used for picnics, cricket, football, hockey, lacrosse, sports, band-concerts, and general recreation. Proposed operations for ensuing year: Laying out a further area for sports, extending present gardens and gradually converting them into botanic gardens, erecting conveniences, and generally improving the area.

AVONDALE DOMAIN.

Section No. 361, Waikomiti Parish. Area, 38 acres 2 roods.

Work done during year: Fences repaired, gate and turnstile erected, and noxious weeds eradicated. Improvements now on domain: Fencing, grassing, and planting. Used for camping. Proposed operations for ensuing year: Fencing and tree-planting.

AWHITU DOMAIN.

Section No. 58c, Awhitu Parish. Area, 8 acres 3 roods 30 perches.

Work done during year: Clearing. Improvements now on domain: Fencing and clearing. Used for picnics. Proposed operations for ensuing year: Clearing and draining.

BIRKENHEAD DOMAIN.

Section No. 122, Takapuna Parish. Area, 112 acres 2 roods.

Six acres leased for grazing.

BUFFALO DOMAIN.

Sections Nos. 31 and 32, Village of Buffalo, Suburbs of Coromandel. Area, 20 acres 1 rood 39 perches.

Work done during year: Clearing, cutting blackberries, and general improvements. Improvements now on domain: Post-and-wire, galvanized-iron, and picket fencing, and gates. Used for football, cricket, sports, and picnics. A military encampment was held on the domain during the year. Proposed operations for ensuing year: Ploughing, levelling, clearing blackberries, and general improvements.

CAMBRIDGE DOMAIN.

Sections Nos. 576, 359, 360, 361, 361a, 367, 581, 578, 579, 363, 363a, 364, 365, 366, 368, and 370, Town of Cambridge East, and the Cambridge East Town Belt. Area, 484 acres 1 rood 7 perches.

A pair of white swans have been presented to the Board by His Majesty the King, and a suitable pen erected for them. The seats and gates have been repainted, and a handsome pair of entrance-gates have been presented and erected by the inhabitants of the district to the memory of the late Mr. Thomas Wells, who was for many years Chairman of the Board. The grounds have been generally maintained, and gorse and weeds cleared. Improvements now on domain: Band-rotunda, pavilion, bowling-greens, tennis-courts, native and ornamental trees, seats, flowerbeds, walks, fences, hedges, and gates. The pavilion and walks are lighted with gas, and the lake is stocked with white and black swans, mallard, paradise, teal, and other ducks. Used for bowls, tennis, band-concerts, picnics, general recreation, and as a promenade. Proposed operations for ensuing year: Generally improving the grounds, procuring another pair of swans, grubbing and clearing gorse and noxious weeds, and clearing raupo from the edges of the lake.

CASNELL ISLAND DOMAIN.

Section No. 196, Mahurangi Parish. Area, 16 acres 3 roods.

Used for camping and picnics.

DEVONPORT DOMAIN.

Allotments Nos. 36, 37, and 39 of Section No. 2, and Mount Victoria Reserve, Takapuna Parish.

Area, 41 acres 2 roods 36 perches.

Work done during year: Cricket-pitch weeded, levelled, top-dressed, and rolled; surface drains attended to; noxious weeds cleared; tennis-court formed, top-dressed, and rolled; paths cleaned; and bowling-green top-dressed and rolled. The cricket-pitch was top-dressed with soil which the Domain Board obtained from Port Albert. Improvements now on domain: Fencing, draining, conveniences, trees, seats, pavilions, cricket and football grounds, and bowling-green. Used for cricket, bowls, tennis, croquet, football, and hockey. From Mount Victoria a splendid view of Auckland and suburbs may be obtained. Proposed operations for ensuing year: Top-dressing and levelling cricket-ground, clearing and repairing path, and general maintenance.

DRURY DOMAIN.

Allotment No. 85 of Section No. 8, Village of Drury. Area, 3 acres and 32 perches.

Work done during the year: One acre and a half ploughed and sown with English grass.

Improvements now on domain: Fencing, clearing, and grassing. Leased for grazing.

EASTERN MAHURANGI DOMAIN.

Section No. 176, Parish of Mahurangi. Area, 108 acres and 15 perches. No works undertaken.

EAST TAMAKI DOMAIN.

Sections Nos. 140 and 40, Pakuranga Parish. Area, 18 acres 1 rood 35 perches.

Work done during year: Noxious weeds cleared and fences repaired. Improvements now on domain: Fencing, plantations, and dam. Used for picnics and grazing. Proposed operations for ensuing year: Clearing noxious weeds and forming roadway to area fenced in for sports.

EPSOM AND MOUNT EDEN DOMAIN.

Work done during year: Scoria-pit fenced in. Proposed operations for ensuing year: Ploughing, levelling, and removing stone from a portion of the domain to prepare an area for cricket, &c.

GATE PA DOMAIN.

Work done during year: Part of domain cleared of gorse and ploughed. Wire has also been obtained for erecting fencing. Improvements now on domain: Fencing, clearing, and grassing.

Concrete tanks cleaned out, path renewed, overgrowth cleared away, and area used for recreation enlarged. Improvements now on domain: Two shelter-sheds, three concrete tanks, wharf, seats, fireplaces, and a well-defined and graded path to the summit of the mountain. Used as a pleasure resort. The island is largely patronized during the summer months, and the Devonport Ferry Company's steamers run frequently. The Domain Board receive the sum of 1d. on each ticket sold. The Board's funds are occasionally supplemented by the sale of blue metal. &c.

Improvements now on domain: Clearing and stumping. Used for grazing. Proposed operations for ensuing year: Fencing.

Work done during year: Ten acres burnt off and sown in grass. Improvements now on domain: Fencing and grassing. Used for picnics, sports, and grazing.

TOTARA DOMAIN.

Section No. 15, Totara Parish. Area, 4 acres 1 rood 5 perches. Improvements now on domain: Embankment and drains. Used for sports.

TUAKAU DOMAIN.

Section No. 45, Tuakau Parish. Area, 37 acres 1 rood 25 perches.

Work done during year: Clearing, hedges trimmed, flowers planted, and ground treated with bonedust and lime. Improvements now on domain: Fencing, plantations, and tennis-court. planted. Improvements now on domain: Picket and post-and-wire fencing, drains, show building, grandstand, and plantations. Used for shows, football, cricket, and hockey.

WAIRIERIE DOMAIN.

Section No. 49, Waikiekie Parish. Area, 53 acres and 32 perches. This domain is under the control of the Commissioner of Crown Lands, Auckland.

WAITAKEREI DOMAIN.

Work done during year: Tracks cut, and grounds generally maintained. Used for picnics and general scenic purposes; also as a catchment area for water.

WAIUKU DOMAIN.

Work done during year: General maintenance and shrubbery cleared. Improvements now on domain: Fencing, draining, pavilion, plantations, and grassing. Used for football, cricket, hockey, and other sports. Proposed operations for ensuing year: Forming new entrance, and erecting gates.

Work done during year: Conveniences erected and 4 acres ploughed and sown in grass. MOTU DOMAIN.

Section No. 174, Block V, Takapau Survey District. Area, 5 acres 2 roods 33 perches.

Improvements now on domain: Fencing, draining, stumping, ploughing, and grassing. Leased for grazing.

ORMOND DOMAIN (PART OF).

Section 82, Block I, Waimata Survey District. Area, 107 acres 1 rood 5 perches.

This portion of Ormond Domain is under the control of the Commissioner of Crown Lands, Napier. There are a number of buildings, also fencing and grassing, on the area. It is proposed to again lease the area on expiry of the present leases.

Work done during year: Fences repaired. Improvements now on domain: Fencing, draining, and plantations. Used for camping, picnics, and bathing. Proposed operations for ensuing year: Draining, forming and metalling road, and erecting stone groin.

NEWMAN DOMAIN.

Suburban Sections Nos. 30 and 115, Town of Newman. Area, 26 acres and 24 perches.

Work done during year: Fence altered, 200 droppers and five new posts inserted, hedge trimmed, and weeds cleared. Improvements now on domain: Fencing, hedge, felling, grassing, stumping, ploughing, shrubs, and trees. Leased. Proposed operations for ensuing year: Fixing copper for picnics, erecting convenience and new gates, trimming hedges, and generally improving the area.

During the year buildings were repaired, fences erected and others repaired, trees planted, water-supply extended, and the domain generally maintained. Proposed operations for ensuing year: Erecting and repairing fences.

ORAUKURA DOMAIN.

Section No. 65, Block XIV, Ohinewairua Survey District. Area, 9 acres 2 roods.

This domain is under the control of the Commissioner of Crown Lands, Wellington. Leased for a term of fourteen years from the 1st January, 1907. Seven acres has been ploughed and sown in rape, and $2\frac{1}{2}$ acres in grass. There are 30 chains of boundary-fences on the domain.

Sections Nos. 5 to 16, Block III, and 5 to 16, 21, 22, and 23, Block IV, Town of Owhango. Area, 7 acres 3 roods 24 perches.

This domain is under the control of the Commissioner of Crown Lands, Wellington. Part of the natural clearing has been levelled,

Work done during year: Spoil carted on to domain, trees planted, and racing-track formed. Improvements now on domain: Fencing, gates, draining, asphalt cricket-pitch, reclamation, building for dressing-room, racing-track, and planting. Used for cricket and general recreation. Proposed operations for ensuing year: Further reclamation and tree-planting.

PAHIATUA DOMAIN.

Situated in Block VIII, Mangahao Survey District. Area, 14 acres 3 roods.

Used for picnics, bathing, and general recreation. Proposed operations for ensuing year: Completing protective works and fencing-in the domain.

PALMERSTON NORTH DOMAIN.

Sections Nos. 215, 220, and part of 214, Kairanga Survey District. Area, 13 acres.

Work done during year: Grass cut from around trees, fences repaired, and dead trees replaced. Improvements now on domain: Fencing, plantations, and native bush. Eight acres leased. Proposed operations for ensuing year: Replacing dead trees, and transplanting young trees if sufficiently advanced.

PARAPARAUMU DOMAIN.

Section No. 5a, Block VIII, Paraparaumu Suburban. Area, 5 acres.

Work done during year: Seats erected in pavilion, rushes and thistles cut, and general maintenance. Improvements now on domain: Fencing, levelling, grassing, gates, tennis-courts, drains, pathway, pavilion, concrete cricket-pitch and seats. Used for cricket, tennis, football, sports, picnics, and general recreation. Proposed operations for ensuing year: Erecting seats and conveniences.

Improvements now on domain: Fencing, gates, planting, felling, and grassing. Used for grazing.

Petone Domain.

Work done during year: Lamps attended to, paths, fencing, and bridge repaired, and gorse and weeds cleared. Improvements now on domain: Paths, bridge, fencing, turnstile, gates, 6 chains cartway, and four lamps. Used as a promenade and as an easy means of access to Korokoro and Maungaraki Settlements. Proposed operations for ensuing year: General maintenance.

Work done during year: One acre stumped. Improvements now on domain: Fencing, grassing, plantation, dam, and stumping. Leased for grazing. Proposed operations for ensuing year: Clearing and levelling.

PUKEOKAHU DOMAIN.

Section No. 17B, Block IX, Pukeokahu Survey District. Area, 6 acres 2 roods 35 perches.

This domain is under the control of the Commissioner of Crown Lands, Wellington. Improvements now on domain: Fencing and grassing. Leased.

Portions of Reserves E and K, Town of Wanganui. Area, 15 acres 3 roods 22 perches.

Improvements now on domain: Fences, plantation, band-rotunda, band-room, museum, and tennis and croquet courts. Used as a public park, and for band-concerts, tennis, and croquet.

Sections Nos. 211 and 290, Town of Raetihi, and 251, Suburbs of Raetihi, and 29, Block VI, Makotuku Survey District. Area, 26 acres and 4 perches.

Work done during year: Belt of trees planted, the trees being donated and planted without cost to the Board; protecting-fence erected, and an area of about $1\frac{1}{2}$ acres stumped and cleared. Improvements now on domain: Fencing, draining, trees, conveniences, gates, tennis-court, stumping, clearing, and grassing. Used for sports and pienics.

RANGATAUA DOMAIN.

Section No. 24c, Block VIII, Makotuku Survey District. Area, 96 acres 1 rood.

Leased for grazing purposes. Improvements now on domain: Fencing. Used for grazing and picnics. Proposed operations for ensuing year: Planting trees and protecting them.

Sections Nos. 6 and 7, Block IX, Town of Rangataua. Area, 10 acres and 5 perches. Very little work was done during the year in connection with this domain.

Work done during year: Scrub cleared and fence erected. Improvements now on domain: Fencing, clearing, and grassing. Five acres leased. Proposed operations for ensuing year: Fencing.

TORERE DOMAIN.

Sections Nos. 43, 44, and 45, Torere Village. Area, 11 acres 1 rood 19 perches. No improvements effected.

TURAKINA DOMAIN.

Section No. 191, Block I, Koitiata Survey District. Area, 85 acres 2 roods. It is proposed to lease the area on improvement conditions.

TUTAEKARA DOMAIN.

Section No. 49, Block XIV, Mangahao Survey District. Area, 9 acres 2 roods 14 perches. Leased on improvement conditions. Used for picnics.

UTIKU DOMAIN.

Sections Nos. 4 and 5, Block I, Potaka Township. Area, 5 acres and 11 perches.

Under the control of the Commissioner of Crown Lands, Wellington. Improvements now on domain: Fencing, felling, stumping, grassing, and shed.

WAIONE DOMAIN.

Section No. 14, Block III, Mount Cerberus Survey District. Area, 6 acres.

Improvements now on domain: An area stumped and levelled for a cricket-ground. Used for cricket and grazing. Leased.

WAIOPEHU DOMAIN.

Section No. 43, Block II, Waiopehu Survey District. Area, 16 acres 2 roods. This domain is fenced on three sides.

WAIOURU DOMAIN.

Section No. 15, Wajouru Township (Suburban). Area, 9 acres and 1 perch. This domain is under the control of the Commissioner of Crown Lands, Wellington.

WAIROA DOMAIN.

Runs Nos. 2, 3, and 4, Block XI, Wairoa Survey District. Area, 229 acres 2 roods.

Work done during year: Cookhouse and shelter-shed erected, fences repaired, and shrubs and trees attended to. Improvements now on domain: Building, swings, fencing, plantation, well and pump. Used for fishing, camping, and picnics. Proposed operations for ensuing year: Building dressing-shed, and planting sand-grass and trees.

Improvements now on domain: Stumping, levelling, and clearing. Used for football, cricket, picnics, sports, hockey, and general recreation. Proposed operations for ensuing year: Clearing timber and fencing.

BRITANNIA HEIGHTS DOMAIN.

Parts of Sections Nos. 1 and 4, Suburbs of Nelson. Area, 11 acres 2 roods 24 perches. Improvements now on domain: Fencing and planting. Used for general recreation.

BULLER DOMAIN.

Section No. 35, Block IV, Kawatiri Survey District. Area, 200 acres. No improvements effected.

DENNISTON DOMAIN.

Section No. 5, Block VI, Kawatiri Survey District. Area, 6 acres.

Improvements now on domain: Dressing-shed and drain. Used for football, cricket, sports, and picnics. Proposed operations for ensuing year: Completing formation and top-dressing.

GLOBE HILL DOMAIN.

Section No. 1, Block II, Waitahu Survey District. Area, 3 acres 3 roods 39 perches. Board appointed in November, 1910.

MILLERTON DOMAIN.

Sections Nos. 142 and 263, Town of Millerton. Area, 9 acres 2 roods 36 perches.

Work done during year: Filling-in and levelling-work done, and ground top-dressed and sown in grass. A pavilion has been erected, the work of building, carting timber, &c., being done gratuitously. Improvements now on domain: Filling-in, levelling, grassing, pavilion, toolshed, fencing, and road. Used for military manœuvres, and for football, cricket, tennis, sports, and picnics. Situated in City of Nelson. Area, 21 acres 3 roods 5 perches.

Improvements now on domain: Fencing and planting. Used for general recreation.

Sections Nos. 43, Port of Puponga, and 1, Village of Puponga. Area, 2 acres 1 rood 7 perches. This domain is under the control of the Commissioner of Crown Lands, Nelson.

RABBIT ISLAND DOMAIN.

Area, 2,600 acres of Rabbit Island.

Board appointed, June, 1910.

REEFTON DOMAIN.

Section No. 189, Block IX, Reefton Survey District. Area, 58 acres 2 roods 39 perches.

Work done during year: Fencing and clearing. Improvements now on domain: Grassing, clearing, and fencing. Used for picnics and grazing. Proposed operations for ensuing year: Fencing and clearing.

WAI-ITI DOMAIN.

Part Section No. 156, Block XV, Wai-iti Survey District. Area, 5 acres.

Work done during year: Notice-board erected, fences renewed, and new gate erected. Improvements now on domain: Fences, plantations, clearing, and levelling. Used for picnics. Proposed operations for ensuing year: Extending plantations and generally improving the domain.

WAKEFIELD DOMAIN.

Sections Nos. 1 and 2, Block XVI, Wai-iti Survey District. Area, 5 acres 1 rood 36.8 perches.

Work done during year: Trees and shrubs planted and protected, pump erected, and grounds generally maintained. Improvements now on domain: Cricket-pitch, football-ground, cycling and running track, well, pump, footbridge, trees, and conveniences. Used for cricket, football, sports, and picnics.

WANGAPEKA DOMAIN.

Section No. 31, Block XV, Wangapeka Survey District. Area, 13 acres 1 rood 33 perches.

Work done during year: Two tennis-courts formed, and about 2 acres cleared of scrub and stumps and ploughed. The work has been done by voluntary labour. FLAXBOURNE DOMAIN.

Section No. 10, Block VI, Town of Ward. Area, 14 acres and 32 perches.

Work done during year: Fencing erected around trees, and half an acre planted with ornamental trees and shrubs. Improvements now on domain: Fencing and trees. Proposed operations for ensuing year: Ploughing, levelling, grassing, and fencing.

KAIKOURA DOMAIN.

Sections Nos. 410, Town of Kaikoura, 2 of 267, Suburbs of Kaikoura, and 2, 346, and 349, Block X, Mount Fyffe Survey District. Area, 101 acres 1 rood 2 perches.

Work done during year: Portion top-dressed and sown in grass, the previous grassing not being successful; concrete cricket-pitch laid down, and golf-links formed. Improvements now on domain: Tennis-courts, conveniences, cycling-track, plantations, concrete cricket-pitch, fencing, railings, golf-links, and grassing. Used for tennis, cricket, football, hockey, sports, racing, rifle shooting, and golf. Proposed operations for ensuing year: Erecting new fence and planting trees.

MONKEY FACE DOMAIN.

The domain is of rough formation, without means of access, and is used for grazing purposes. The fencing is the property of the lessee.

OMAKA DOMAIN.

Sections Nos. 31 and part 2 of 33, Block III, Taylor Pass Survey District, and Allotment 4 of Section 45, Opawa District, Block XVI, Cloudy Bay Survey District. Area, 252 acres.

Work done during year: Fencing and protective works erected and trees planted. Improvements now on domain: Fencing, draining, plantations, and sports-ground. Used for sports and grazing. Proposed operations for ensuing year: Filling in hollows and draining.

PELORUS DOMAIN.

Sections Nos. 25, Block VIII, Heringa Survey District, and 66 (Te Hau Island), Block XI, Wakamarina Survey District. Area, 22 acres.

Nine acres of the domain is an island in the Pelorus River, subject to floods; the remaining 13 acres is in native bush.

PICTON DOMAIN.

Part of Section No. 1147, Town of Picton. Area, 9 acres 2 roods.

Work done during year: Noxious weeds kept down. This domain is steep and rocky. It contains some native bush, and an area of about 2 acres suitable for picnics.

Reserve No. 1237, Block II, Mawheranui Survey District. Area, 7 acres.

Work done during year: Fencing, three gates (two small and one large), and shelter-shed erected, and levelling done. A mixture of grass and clover has been sown on all exposed soil. Improvements now on domain: Fencing, shelter-shed, and levelling. Used for picnics. Proposed operations for ensuing year: Planting, levelling, and draining.

COBDEN DOMAIN.

Reserve No. 44, Block IV, Cobden Survey District. Area, 8 acres 1 rood 24 perches. The Board is raising funds for fencing and improving the domain.

DOBSON DOMAIN.

Reserves Nos. 258 and 290, Town of Dobson. Area, 8 acres 2 roods. Used for football and cricket.

KUMARA DOMAIN.

Sections Nos. 815 to 835 (Reserves Nos. 221 and 824) and 778 to 814 (Reserve No. 255), Town of Kumara. Area, 7 acres 1 rood 13 perches.

Improvements now on domain: Fencing, draining, and grassing. Used for football, hockey, and cricket.

OKARITO DOMAIN.

Reserve No. 201, Block II, Okarito Survey District. Area, 140 acres. No improvements effected.

Ross Domain.

Situated in Town of Ross. Area, 3 acres 3 roods 16 perches.

Work done during year: Drain formed, fencing erected, bank removed, and water laid on. Improvements now on domain: Fences, drains, cricket-pitch, ornamental trees, sheds, conveniences, and water-service. Used for cricket, football, sports, and picnics. Proposed operations for ensuing year: Levelling and tree-planting.

RUNANGA DOMAIN.

Reserve No. 361, Block XXXIX, Town of Runanga. Area, 19 acres 3 roods 16 perches.

Work done during year: Felling and burning. Funds were raised locally. Proposed operations for ensuing year: Grubbing, clearing, levelling, and grassing.

CANTERBURY LAND DISTRICT.

AKAROA DOMAIN.

Reserves Nos. 88 and 1724, Akaroa Survey District, and Section No. 45, Town of Akaroa. Area, 10 acres 2 roods.

Work done during year: Trees thinned out, walks and paths cleaned and repaired, fences attended to, and native trees and shrubs planted. Improvements now on domain: Fences, hedges, summerhouse, blockhouse, two bridges, fountain, water-supply, gates, seats, asphalt tennis-court, and avenue of trees and shrubs. Used for tennis, picnics, and general recreation. Proposed operations for ensuing year: General maintenance.

Work done during year: Fences repaired and gorse and broom grubbed. Improvements now on domain: Fencing, trees, and grassing. Leased. Proposed operations for ensuing year: Replacing failures in plantations.

AROWHENUA DOMAIN.

Reserves Nos. 3003 to 3013, and 3412, Town of Arowhenua. Area, 10 acres 2 roods 38 perches.

During the year the course of the creek running through the domain has been kept clear of weeds. A permanent hand is employed for the purpose. Leased for cropping and grazing.

ARUNDEL DOMAIN.

Reserve No. 2965, Block III, Town of Arundel. Area, 4 acres 1 rood 6 perches.

Work done during year: Hedges trimmed, gorse grubbed, trees topped, and trees dug around. Proposed operations for ensuing year: Erecting new gate and attending to fences.

Improvements now on domain: Superintendent's house, watchman's house, winter-garden, two propagating-houses, plant-frames, bush-house, fernery, tool-house, band-rotunda, three bridges, running-track, aviary, deer-pen, gates, seats, cloak-room, summerhouse, rock-garden, maze, plantations, flower beds and borders, and potting-shed. Used as a botanic garden, and for cricket, football, sports, and picnics. Proposed operations for ensuing year: Extending rock-garden, erecting tea-kiosk, altering paths, and adding to rose-garden. The collection of native plants has been extended. Permanent labels have been placed on the exotic plants, and it is hoped to label the native and alpine plants in a similar manner. The new water-supply has been a great success, and has enabled the Board to maintain the display of flowers right through the season.

DUNSTAN DOMAIN.

Section No. 72, Block I, Leaning Rock Survey District. Area, 135 acres 3 roods 21 perches. Used for races.

DUNTROON DOMAIN.

Section No. 23, Block IV, Maruwenua Survey District. Area, 80 acres.

Work done during year: Rabbits kept down, football-ground and sports-ring formed, fencing erected, trees planted, grass sown, and conveniences erected. Improvements now on domain: Rabbit-proof fencing around sports-ring, conveniences, and trees. Used as a rifle range and for sports, picnics, and grazing. Proposed operations for ensuing year: Keeping down rabbits and clearing gorse.

Part of Section No. 2 of 22, Block VII, Oamaru Survey District. Area, 47 acres 3 roods 19 perches.

Work done during year: Windmill and concrete water-trough erected. Improvements now on domain: Fencing, plantations, creamery, dwelling, windmill, and water-trough. Used for grazing, football, golf, and picnics.

MANUHERIKA DOMAIN.

Section No. 1, Block XXXVII, Town of Alexandra. Area, 96 acres 3 roods 5 perches.

. Work done during year: Trees planted. Improvements now on domain: Golf-links, racing-track, and conveniences. Used for golf and racing. Proposed operations for ensuing year: Inserting pipes for water-supply.

MAUNGATUA DOMAIN.

Section No. 22, Block XI, Maungatua Survey District. Area, 566 acres. Used for picnics and grazing.

MID-WAKATIPU DOMAIN.

Section No. 39, Block IV, Mid-Wakatipu Survey District. Area, 400 acres.

This domain is under the control of the Commissioner of Crown Lands, Dunedin. No works have been undertaken.

MOA FLAT AND ETTRICK DOMAIN.

Section No. 44, Block I, Benger Survey District. Area, 420 acres

This domain is administered by the Commissioner of Crown Lands, Dunedin, and is held under pastoral license.

MOERAKI DOMAIN.

Sections Nos. 15, Block II. 13, Block III, and 4, 5, 6, and 7, Block XIV, Town of Moeraki. Area. 23 acres 3 roods 34 perches.

Work done during year: Entrance formed to bath paddock, hedge and trees planted, hedges trimmed, and trees cleared of weeds. Owing to the dry season most of the trees died. Improvements now on domain: Fencing and planting. Used for picnics and grazing. Proposed operations for ensuing year: Planting trees, clearing stones, levelling portions of the bath paddock, and eradicating gorse, &c.

NASEBY DOMAIN.

Section No. 23, Block I, Naseby Survey District. Area, 120 acres.

Improvements now on domain: Grandstand, racing-track, and fencing. Used for racing.

OCEAN BEACH DOMAIN.

Sections Nos. part 28 and 31, Block VII, Otago Peninsula Survey District, and 4 and 6, Block XII, Dunedin and East Taieri Survey Districts. Area, 221 acres 2 roods 11 perches.

Salt-water baths have been installed since last year, and are proving a great success. The swimming-baths have been frequented by a very large number of bathers. The St. Clair beach has not improved during the year, westerly winds having caused a continuous scour. Unusually heavy pedestrian traffic has also tended to reduce the level of the beach for a distance of some chains. The progress at St. Kilda beach has been slow compared with past years, caused by the absence of south-west winds, which usually bring up a supply of sand. Tracks have been cut through the lupins, and, where possible, covered with clay. Surf bathing has become a popular pastime. It is proposed to have an area prepared for tree-planting, and also to plant marramgrass and lupins where required. Reclamation and general maintenance will also be continued. (NOTE.—This report is for the year ended 31st March, 1911.)

OTORIA DOMAIN.

Section No. 47, Block I, Otokia Survey District. Area, 12 acres 2 roods.

Work done during year: New chain for horse-stand provided. Improvements now on domain: Fencing, post-and-chain horse-stand, notice-board, lifebuoy and line. Used for grazing, picnics, and sports.

OUTRAM DOMAIN.

Sections Nos. 31 and 32, Block VII, Maungatua Survey District, and 14 to 20, and 22, Block I, and 7, Block XV, Town of Outram. Area, 402 acres 1 rood 5 perches.

Work done during year: Asphalt tennis-court formed, fences repaired, hedges trimmed and grounds generally maintained. Improvements now on domain: Buildings, plantations, hedges, fences, swings, seats, pump, tennis-courts, bowling-green, and water-supply. Used for bowls, tennis, football, sports, cycling, picnics, general recreation, and grazing. Proposed operations for ensuing year: Maintaining and renewing fences and trimming hedges.

OWAKA TOWNSHIP DOMAIN.

Section No. 111 (formerly part of Section No. 3), Block VIII, Glenomaru Survey District. Area, 3 acres 3 roods 0.8 perches.

During the year a shed was erected on the domain. Improvements now on domain: Tenniscourt, cricket-pitch, swings, fences, gates, and turnstile. Used for cricket, football, sports, shows, picnics, and military manœuvres.

PALMERSTON DOMAIN.

Sections Nos. 5 to 18, Block XVI, Town of Palmerston. Area, 3 acres 2 roods.

Work done during year: Fences repaired. Improvements now on domain: Boundary-fence. Used for cricket, football, and general recreation.

POUNAWEA DOMAIN.

Sections Nos. 31, 53, 54, 55, 58, 59, 60, and 61, and a closed road, Block VI, Glenomaru Survey District. Area, 13 acres 1 rood 16 perches.

Work done during year: One acre cleared, stumped, burned, and sown in grass. Improvements now on domain: Eighteen chains fencing, of which 5 chains is wire netting, 5½ acres cleared and sown in grass; trees, and gate. Used for camping and picnics, also by tourists. Proposed operations for ensuing year: Stumping, clearing, and burning.

QUEENSTOWN DOMAIN.

Blocks LIV, LV, and LVI, Town of Queenstown. Area, 7 acres and 19 perches.

Improvements now on domain: Fences and trees. Used for forestry purposes. Proposed operations for ensuing year: Fencing remainder of domain and planting trees.

ROSLYN DOMAIN.

Section No. 7, Block X, Dunedin and East Taieri Survey District. Area, 12 acres 2 roods 28 perches.

Work done during year: Roads and tracks repaired. Leased for grazing.

ST. BATHAN'S DOMAIN.

Section No. 25, Block II, St. Bathan's Survey District. Area, 23 acres 1 rood 5 perches.

The work of clearing the domain of broom and gorse was commenced at the end of the year. Improvements now on domain: Forty-five chains fences, four gates, trees, hedges, curling and skating pond, football and cricket grounds, and two running-tracks. Used for sports and public recreation. Proposed operations for ensuing year: Completing clearing of domain.

TAIERI LAKE DOMAIN.

Sections Nos. 12 and 18, Block XI, and 2, Block XII, Maniototo Survey District, and 67 to 81, Town of Komako. Area, 436 acres and 39 perches.

Work done during year: Sixty chains fencing erected and 26 chains removed. Improvements now on domain: Fencing, planting, and embankment. Used for grazing and general recreation. Proposed operations for ensuing year: General improvements and tree-planting.

TOKOMAIRIRO DOMAIN.

Parts of Sections Nos. 103 and 104, Block XII, Tokomairiro Survey District. Area, 59 acres 2 roods 30 perches.

Work done during year: Paths, flower-beds, and grounds maintained; hedges cut and trimmed; and trees and shrubs planted. Improvements now on domain: Plantations, drains, fences, ponds, flower-beds, and paths. Used for football, cricket, and picnics. Proposed operations for ensuing year: Attending to grounds, and planting shrubs, flowers, and trees.

TROTTER'S CREEK DOMAIN.

Section No. 36, Block XI, Moeraki Survey District. Area, 183 acres and 11 perches.

Work done during year: Scrub and undergrowth cleared and seats erected. Improvements now on domain: Footbridge, seats, and tracks. Used for picnics. Proposed operations for ensuing year: Further clearing, and erection of seats.

TUAPEKA DOMAIN.

Blocks XV, XVI, XVIII, XIX, XXXV, Sections Nos. 1 to 8, 10 and 13 to 16, Block XIV, 1 to 7, and 20, Block XVIII, 1 to 6 and 17 and 18, Block XXXIV, 6, Block LIII, 3, 4, and 5, Block LIV, and three areas containing 1 rood, 2 roods 35 perches, and 3 roods 24 perches respectively, Town of Lawrence, Section 9, Block LIV, Town of Lawrence, and Sections Nos. 20 and 30, Block XIX, Tuapeka East Survey District. Area, 128 acres 3 roods 17 perches.

Work done during year: Trees, shrubs, and flowering-plants planted, wire-netting fence erected to protect young trees, old fences replaced, paths on Reservoir Hill put in order, and side

channels attended to. Improvements now on domain: Fencing and plantations. Used for hockey, cricket, football, shows, military encampments, sports, and generally as a pleasure resort. Proposed operations for ensuing year: Further tree-planting and protection with wire netting.

WAIHEMO DOMAIN.

Section No. 74, Block IV, and parts of Sections Nos. 56 and 58, Block X, Moeraki Survey District. Area, 139 acres 1 rood 5 perches.

Work done during year: Hedges trimmed, trees and shrubs weeded, fish-pond completed, tile drains constructed, and paths formed and sown in grass. A cycle-track is in course of construction; it is proposed to complete it during the ensuing year.

WAIKOUAITI DOMAIN.

Situated in Town of Hawksbury. Area, 448 acres 2 roods 26 perches.

Work done during year: Filling-in work continued and trees planted. Improvements now on domain: Canal and connecting-drains, fencing, reclaimed area, plantations, embankments, bridges, pavilions, bowling-green, and tennis-courts. Used for sports, races, picnics, bowls, tennis, cricket, football, hockey, and grazing. Proposed operations for ensuing year: Improving recreation-ground and planting trees.

Improvements now on domain: Fencing and trees. Used for picnics and general recreation Proposed operations for ensuing year: Ploughing and sowing down the domain in grass.

Work done during year: Roads and tracks repaired, Manuka Island wharf repaired, hut erected. The hut has been erected near Mount Aspiring, and will be greatly appreciated by visitors. Improvements now on domain: Fencing, plantations, wharves, huts, marram-grass planting, and tracks. Used for sports, picnics, as a sanctuary for flightless birds, and as a study-ground of nature. Proposed operations for ensuing year: Planting trees and shrubs along Bullock Creek, forming dam with a view to introducing foreign fish, and reclaiming and beautifying an area in the Town of Pembroke.

WANGALOA DOMAIN.

Part of Section No. 8, Block VII, Coast Survey District. Area, 32 acres 3 roods 13 perches.

Improvements now on domain: Fences, drains, and plantations. Used for picnics and sports.

WILLSHER DOMAIN.

Sections Nos. 1, 3, and 4 of 16, and an intersecting road-line, Block VII, South Molyneux Survey District. Area, 14 acres and 39 perches.

Improvements now on domain: Draining, seats, fencing, tennis-court, racing-track, and trees. Used for sports and picnics.

BRYDONE DOMAIN.

Section No. 152E, Block II, Brydone Village. Area, 4 acres 3 roods.

Work done during year: Trees planted. Improvements now on domain: Fencing, trees, and grassing. Used for picnics, cricket, and football. Proposed operations for ensuing year: Erecting building and replacing failures in trees.

The cost of the improvements effected during the year was paid by the racing club and residents of the district.

• Work done during year: Weeds eradicated and rabbits kept down. Improvements now on domain: Fencing. Used for picnics. The whole of the area is covered with native bush.

DIPTON DOMAIN.

Section No. 3, Block X, Town of Dipton. Area, 5 acres.

Improvements now on domain: Fences, trees, grassing, shelter-shed and outhouses, and concrete well. Used for sports and picnics.

FORTROSE DOMAIN.

Section No. 42, Block IV, Town of Fortrose. Area, 10 acres.

Work done during year: Hedges cut and trimmed. Improvements now on domain: Four acres plantation, fencing, hedge, and hut. Used for sports and picnics. Proposed operations for ensuing year: Erecting dividing-fence, and forming and sowing down in grass a running-track.

GORE DOMAIN.

Situated in Towns of Gore and East Gore. Area, 98 acres and 6 perches.

Work done during year: Gardens kept in good order, glasshouse erected (by Borough Council), and fencing repaired. A caretaker is employed. Improvements now on domain: Fencing, plantations, gardens, two bowling-pavilions, two tennis-pavilions, and glasshouse. Proposed operations for ensuing year: General maintenance.

HAPFY VALLEY DOMAIN.

Section No. 7, Block III, Waikaia Survey District. Area, 55 acres 2 roods.

Work done during year: Twenty-three chains new fencing erected. Proposed operations for ensuing year: Fencing-in 2 acres to protect trees.

LIMEHILLS DOMAIN.

Sections Nos. 1 to 7 and 8 to 17, Block IV, Town of Limehills. Area, 4 acres 2 roods 6 perches.

Work done during year: Fencing and gate erected. Improvements now on domain: Fencing, draining, trees, shed, cricket-pitch, and tennis-court. Used for cricket, tennis, sports, and grazing. Proposed operations for ensuing year: Cutting gorse and trimming trees.

LUMSDEN DOMAIN.

Sections Nos. 1 to 6, Block XXIII, Town of Lumsden. Area, 19 acres 1 rood 4 perches Leased.

MAKAREWA DOMAIN.

Section No. 1, Block VIII, Town of Makarewa. Area, 13 acres and 18 perches.

Improvements now on domain: Ploughing, grassing, and fencing. Used for general recreation. Proposed operations for ensuing year: Cutting drains and watercourses.

MATAURA DOMAIN.

Sections Nos. 39, 40, and 41, Block XVII, Town of Mataura Bridge, and 13, Block XII, Town of Mataura. Area, 18 acres 1 rood 18 perches.

Work done during year: Portion of domain sown in grass and macrocarpa hedge planted. Improvements now on domain: Fences, trees, hedges, and grandstand. Used for sports and picnics

OMAUI DOMAIN.

Section No. 69, Block V, Campbelltown Hundred. Area, 158 acres 2 roods 29 perches. Not used by the public. Covered with native bush, which is being protected.

OTAUTAU DOMAIN.

Sections Nos. 1 to 5, 7 to 12, 17 to 22, and 24 to 28, Block IX, 1 to 5, 7 to 13, 17 to 23, and 25 to 29, Block X, 1 and 32, Block XI, 1 and 27, Block XII, 1 and 23, Block XVI, 1 and 24, Block XVII, and 1 and 24, Block XVIII, Town of Winton. Area, 14 acres.

Work done during year: Bowling-green formed and pavilion erected, asphalt tennis-courts laid down, and buildings and fencing erected. The works have been carried out by the bowling and tennis clubs. Improvements now on domain: Stumping, ploughing, trees, seeds, planting, fencing, bowling-green, tennis-courts, and buildings. Used for bowls, tennis, also for grazing and plantation purposes.

WYNDHAM DOMAIN.

Section No. 66, and a lagoon of 12 acres in Block VI, Town of Wyndham. Area, 25 acres.

Work done during year: Domain cleared of weeds and gorse. Improvements now on domain: Trees, shrubs, flowers, fencing, and draining. Used as a pleasure resort. Proposed operations for ensuing year: Erecting bridge across the lagoon and planting shrubs.
