CROWN LANDS REMAINING FOR FUTURE DISPOSAL

(PARTICULARS RELATIVE TO).

Return to an Order of the House of Representatives dated the 19th October, 1910.

Ordered, "That there be laid before this House a return relative to the 4,282,284 acres of Crown lands remaining for future disposal (vide Table 1, Lands Report, 1910), showing—(1) The class of land; (2) the provincial districts within which situated; and (3) the approximate value of the land."—(Mr. FISHER.)
