Work done during year: Paths, channels, and culverts renewed and kept in order; shrubs attended to; substantial fences erected; new gates erected; new seats set in cement and placed over the domain in view of the bay; fences and gates painted; tool-house erected; and roads formed to the mountain top; a new reservoir has been formed on the top of the mountain capable of holding a million gallons.
