COMPULSORY TAKING OF ESTATES

(PARTICULARS OF LAW-COSTS PAID BY THE CROWN IN CONNECTION WITH).

Return to an Order of the House of Representatives dated the 8th August, 1913.

Ordered, "That there be laid before this House a return showing—(1) The amount of law-costs paid by the Crown in connection with the compulsory taking of estates under the Land for Settlements Act; and (2) the names of the firms or individuals to whom such costs were paid, and in each case the name of the estate and the dates and periods for which such services were rendered."—(Mr. Scott.)

RETURN showing—(1) The AMOUNT of LAW-costs paid by the Crown in connection with the Compulsory Taking of Estates under the Land for Settlements Act; (2) the NAMES of the FIRMS or INDIVIDUALS to whom such Costs were paid, and in each Case the NAME of the ESTATE and the DATES and PERIODS for which such Services were rendered.
