Ordered, "That Standing Order No. 219 be suspended, and that a Select Committee be appointed, consisting of eleven members, to consider all petitions from A to L that may be referred to it by the Petitions Classification Committee; to classify and prepare abstracts of such petitions in such form and manner as shall appear to it best suited to convey to this House all requisite information respecting their contents, and to report the same from time to time to this House, and have power to report its opinions and observations thereon to this House; also to have power to call for persons and papers; three to be a quorum; the Committee to consist of Mr. Brown, Mr. P. Fraser, Mr. Harris, Mr. Parr, Mr. Payne, Mr. T. W. Rhodes, the Hon, Mr. Russell, Mr. G. H. Smith, Dr. Thacker, Mr. Wright, and the mover."—(Right Hon, Mr. Massey, for Minister in Charge, Hon, Mr. Hine.)

No. 47.—Petition of C. R. CHOLMONDELEY-SMITH, of Oneroa.

Praying that he may receive the military medals for service in the Maori War.

I am directed to report that in the opinion of the Committee this petition should be referred to the Government for favourable consideration.

No. 45.—Petition of W. H. CLARKE and 21 Others, of Auckland.

Praying that they receive the full military pension together with the old-age pension.

I am directed to report that in the opinion of the Committee the Government should be requested to legislate so that military pensioners should be allowed to receive the additional benefit of the old-age pension.

No. 1 of 1918.—Petition of F. G. DALZIELL, of Wellington.

Praying that legislation be enacted so that the natural resources of the Dominion could be thoroughly developed.

No. 108 .- Petition of ELSIE MARY HILL, of Christehurch.

Praying that the payment of £100 gift duty on the sum of £2,000, personally supplemented by the Hon. W. F. Wigram to an equal sum, for which a trust was formed for her benefit and the benefit of her children, be refunded.

I am directed to report that the Committee is of opinion this petition should be recommended to the Government for favourable consideration, and that the prayer of the petitioner be granted. 24th September, 1919.

No. 12 of Session II, 1918.—Petition of PATRICK CONRICK, of Porirua.

Praying that he be compensated for alleged wrongful arrest in connection with his being called up for military service, and that he be refunded his travelling-expenses.

1 am directed to report that the Committee has no recommendation to make with regard to this petition.

No. 485 of 1917.—Petition of John Jamison, sen., of Dunedin.

Praying that an inquiry be made into certain correspondence with the Soldiers' Financial Assistance Board.

No. 104 of Session II, 1918.—Petition of Leyland-O'Brien Company (Limited), of Auckland. Praying for compensation for loss sustained through the seizure of their vessel by the escaped German prisoners.

I am directed to report that the Committee is strongly of opinion that the Government should grant reasonable compensation to the petitioners.

No. 280.—Petition of W. J. ALEXANDER, of Auckland.

PRAYING for compensation for losses sustained by the refusal by the Administrator for permission to land at Samoa.

I am directed to report that the Committee has no recommendation to make.

No. 122 of Session II, 1918.—Petition of Philip Bailey, of Dannevirke.

Praying that he may be granted adequate compensation for injuries received during an alleged illegal assault committed by a returned soldier named Sergeant White.

I am directed to report that in the opinion of the Committee this petition should be referred to the Government for consideration.

Nos. 64, 65, and 66 of Session II, 1918.—Petitions of M. L. BAMBERRY, I. M. P. BURKE, and M. E. BURKE, all of Ravensbourne.

Praying for compassionate allowance for injuries sustained through the alleged negligence of the Defence authorities in allowing one Onslow Mayhew to retain the use of firearms.

I am directed to report that in the opinion of the Committee the Defence Department is in no way to blame, but, in view of the distressing circumstances, it recommends the several petitions to the favourable consideration of the Government.

Praying that all enemy aliens be interned.

Praying for compensation for alleged wrongful detention in a mental hospital.

No. 487 of 1917.—Petition of W. A. D'ORIDANT, of Oamaru.

Praying that he may be granted compensation for the loss of his fishing-launch by the foreclosure of a mortgage.

## No. 1.—Petition of Patrick Lundon, of Wellington.

Phaying that he be granted the amount of money to which he claims he is entitled for overtime worked in the Internal Affairs Department.

#### No. 277.—Petition of B. B. Walton and Others, of North Otago.

Praying for assistance to the surviving victims of the Gemmell's Crossing tragedy.

I am directed to report that in the opinion of the Committee the Defence Department is in no way to blame, but, in view of the distressing circumstances, it recommends this petition to the favourable consideration of the Government.

No. 262.—Petition of MARY A. HARDING, of Palmerston North. (First Report.)

Praying for a reduction of the death duties on a deceased relative's estate.

I am directed to report that, in view of the existing legislation, the Committee has no recommendation to make.

#### No. 56.—Petition of R. J. Acheson, of Wairarapa.

Praying for a compassionate allowance or increase of his superannuation so as to provide a living for his wife.

I am directed to report that, owing to the very special circumstances that have arisen since the petition was presented, the Committee have no recommendation to make, but would strongly urge upon the Government that the charge for Mr. Acheson's maintenance in the mental hospital be remitted.

## No. 119.—Petition of C. A. BLOOMFIELD, of Southland.

Praying for a gift of grass-seed to enable him to grass an area of burnt bush land, which he is unable to do without such help, being totally blind.

I am directed to report that upon this petition the Committee has no recommendation to make, but would urge upon the Government the great need for introducing legislation making provision for the sustenance of blind people.

#### No. 120.—Petition of C. A. BLOOMFIELD, of Southland.

Praying for assistance to provide transport to New Zealand for his nephew and his wife and child, to help him on his farm, he himself being totally blind.

I am directed to report that the Committee is of opinion the petition should be referred to the Government for favourable consideration.

Praying for half civil pay while members of the New Zealand Army Postal Service.

Praying that he may be awarded the Maori War Medal for services rendered during the Maori War.

Praying for compensation for loss of wages and a refund of legal expenses incurred through alleged wrongful arrest.

No. 242.—Petition of Elizabeth A. Coleman, of Christchurch.

Praying for a compassionate allowance on account of the services rendered by her late husband while he was a member of the New Zealand Defence Force.

I am directed to report that in the opinion of the Committee this petition should be referred to the Government for consideration.

Praying for a compassionate allowance on account of the loss of her husband, who was a member

I am directed to report that the petitioner should apply for the war pension under the provisions of section 16, subsection (1) (b), of the War Pensions Amendment Act, 1917; and, further, that the Committee directs the attention of the Government to clause 13 of the departmental report on this petition.

I am directed to report that the Committee is of opinion this petition should be referred to the Government for favourable consideration.

No. 262.—Petition of Mary A. Harding, of Palmerston North. (Second Report.)

Praying for reduction of the death duties on a deceased relative's estate.

I am directed to report that, on account of existing legislation, the Committee has no recommendation to make on the prayer of the petition, but recommends that legislation should be introduced making a reduction on death duties where the successors die within a year of each other, thus following on the lines of the Death Duties Act, 1914, and Finance Act, 1914, of the Imperial Parliament.

PRAYING for the repeal of clause 9 of the Selwyn County Subdivision Act, 1910.
