society or branch to meet any contributions payable by that society or branch to a medical society shall be deemed to be a debt due from the member to his society or branch, and shall be recoverable

It has been found that some societies have invested benefit funds in Harbour Board debentures, which are not a security authorized by the principal Act. Such investments have been validated by the amending Act of 1922, but no statutory authority is given for future investments of that nature. The amending Act also provides that all fines imposed on its members by a registered friendly society or registered branch pursuant to its rules shall be recoverable by summary proceedings.
