AUDIT OF ACCOUNTS OF LOCAL AUTHORITIES.

I am pleased to state that the position disclosed in my last report regarding the work of auditing the accounts of local authorities has been well maintained during the past year.

The duties of the Audit inspecting staff increase progressively with the development of the local authorities' districts, and, in addition, the work has recently been added to by the necessity for undertaking the auditing of expenditure on works carried out by local authorities under the unemployed-relief schemes.

Local Authorities' Finance.—Local authorities are required by law to provide for their ordinary obligations in each year out of the revenue of that year, and their power of borrowing on overdraft or temporary loan is limited at the end of the year by the amount of revenue outstanding at that date.
