Mr. Carr, Mr. Hawke, Mr. Kyle, Mr. Linklater, Mr. Lye, Mr. J. N. Massey, Mr. McSkimming, Mr. Stallworthy, Mr. Semple, and the mover."— (Hon. Mr. Young.)

### THURSDAY, THE 13TH DAY OF OCTOBER, 1932.

Ordered, "That all petitions not finally dealt with during the session of 1931 be again referred to the same Committees as they were referred to during the said session, and that all petitions received during the first session of 1932 be dealt with as if they had been received this session."—(Right Hon. Mr. FORDES.)

Ordered, "That all petitions referred to the Railways Committee during the session of 1931 and not finally dealt with during that session be referred to the appropriate Public Petitions Committee set up during the present session."—(Right Hon. Mr. FORBES.)

Ordered, "That the report of the Public Petitions M to Z Committee on the petition of Rebecca MacRae be referred back to the Committee for further consideration."—(Mr. O'BRIEN.)
