WHANGAREI HARBOUR BOARD VESTING BILL.

THE LOCAL Bills Committee, to which was referred the above-mentioned Bill, has the honour to report that it is a Local Bill; that the Standing Orders have been complied with; and that the rights and prerogatives of the Crown are affected, inasmuch as the Bill provides for the vesting in the Whangarei Harbour Board, as endowment lands, of two areas of Crown land and an education reserve.

CHRISTCHURCH CITY RESERVES AMENDMENT BILL.

The Local Bills Committee, to which was referred the above-mentioned Bill, has the honour to report that it is a Local Bill; that Standing Orders 361, 362, 364, and 366 have not been fully complied with, but were suspended by the House; that the rights and prerogatives of the Crown are affected, as the land concerned is a reserve subject to the provisions of the Public Reserves, Domains, and National Parks Act, 1928.

ONEHUNGA AND ONE TREE HILL BOROUGHS WATER-SUPPLY PROTECTION BILL.
