#### HUTT COUNTY RATING BILL.

The Local Bills Committee, to which was referred the above-mentioned Bill, has the honour to report that it is a Local Bill; that the Standing Orders have been complied with, with the exception of Standing Order 366, which, in so far as it relates to the number of days from the commencement of the session within which Local Bills may be introduced, was suspended by the House to enable the Bill to proceed; that the rights and prerogatives of the Crown are affected by the Bill, as introduced, in the following respects:—

(a) The exemption from rating provided for in clause 2 does not include cases where the

Crown, as mortgagee, is not now liable for rates; and
(b) Public-school properties vested in the Wellington Education Board would become liable for rates; and as the greater part of the Board's income is derived from the Education Department, the charge would presumably fall on the Crown.

That the Committee recommends that the Bill be not allowed to proceed, pending the Report of the proposed Rural Local Government Commission.
