ORDERS OF REFERENCE.

TUESDAY THE 10TH DAY OF JULY, 1934.

Ordered, "That a Select Committee be appointed, consisting of ten members, to consider all matters pertaining to agricultural and pastoral industries and stock which may be referred to it; with power to confer and sit together with any similar Committee which may be appointed by the Legislative Council, and to agree to a joint or separate report: the Committee to consist of Mr. Burnett, Mr. Coleman, Mr. Kyle, Mr. Langstone, Mr. Lye, Mr. W. W. Massey, Mr. Polson, Mr. Reid, Mr. Savage, and the Mover."—(Hon. Mr. MACMILLAN.)

THURSDAY, THE 26TH DAY OF JULY, 1934.

Ordered, "That all petitions referred to the Public Petitions A to L (Supplementary) Committee and the Public Petitions M to Z (Supplementary) Committee during the session of 1933, and not finally dealt with, be referred to the Public Petitions A to L and M to Z Committees respectively, and all other petitions not finally dealt with during the session of 1933 be again referred to the same Committees as they were referred to during the said session."—(Right Hon. Mr. FORBES.)

TUESDAY, THE 31ST DAY OF JULY, 1934.

Ordered, "That the Scientific and Industrial Research Amendment Bill be referred to the Agricultural and Pastoral Committee."—(Right Hon. Mr. FORBES.)

I have the honour to report that, in view of the stringent quarantine regulations now in operation, both in England and New Zealand, and as a result of the evidence submitted, the Committee is of the opinion that the prayer of the petitioners should be referred to the Government for favourable consideration.
