The records show that, of the numbers dealt with, 261 had been before the Courts for previous offences, but many of these were of a minor nature, and there is every reason to hope that these children will make good with a little friendly supervision.

In addition to the above, there were 28 cases dealt with by the Magistrates under the provisions of section 17 of the Child Welfare Amendment Act, 1927, and the informations dismissed as trivial; while there were also 85 cases in which, as a result of consultation between the Child Welfare Officer and the police, the informations were regarded as of insufficient importance to warrant Court action, the children concerned being adequately dealt with otherwise, usually as preventive cases under the supervision of a Child Welfare Officer for a period.
