THE ELECTIONS AND THE LAND QUESTION IN OTAGO.

In may be taken for granted that, during the ensuing elections, thoughtful and commonly sensible men will pay very little attention to what is called the constitutional question. It is to be regretted that a dissolution should have been the result of the agitation of this question; and that so much eloquence is being now expended upon it. No one will be disposed to deny the ability, ingenuity, and facility of expression of the leaders of the constitutional party. But all these are compatible with an absence of common sense; and though entertaining great respect for these leaders, we cannot persuade ourselves that on this occasion they are not unreasonable.

On reading their speeches, it struck us they are the square pegs in the round holes. This Province is not their sphere; the Imperial Parliament is the loser by their being placed at so great a distance from the constitutional machine in Westminster, were they there they might grind away, and few would be disposed to find much fault with them. The House of Commons always contains a certain number of gentlemen who regard themselves as the tutelary divinities of the British Constitution, and, as no great harm results, men have made up their minds to meet the inevit-

able with decent resignation.

But in a new and very progressive country, in a Provincial Council which has no independent legislative power, and whose business it is to manage such affairs as fall under the care of Grand Juries in England, it is really too bad to have time and money wasted in a burlesque on the Imperial The electors will do well to consider if the Parliament, business of the Province could not be conducted better and

Common sense and common honesty are all the

people want, and indeed all the people pay for.

Instead of making this constitutional question the point on which elections should turn, it would be much more to the purpose to examine the real state of the law and its administration in reference to the Crown lands of the Province. It is admitted on all hands that the prosperity of the country depends on the wise and rapid disposal of these lands. If industrious people be not settled on them in very large numbers, the Public Works Scheme will bring ruin, instead of promoting progress. The great question, then, is, which of the contending parties in Otago is the most favourable to the alienation of Government land on reasonable terms? Or, is either party really anxious to settle people on the land? These are two very important questions, the most important that can engage the attention of electors at this time.

We regret it is not in our power to afford much aid in the solution of these knotty points. Our difficulty arises from our unwillingness to say anything for or against any party. We belong to none, and we are convinced every party contains many honest men, who, though perhaps mistaken in their views, mean the promotion of the public good. These ideas restrain our pen, and we are not sorry it should be so, considering that the electors themselves know the candidates best.

One thing, however, is certain, that it is not always the man who is loudest in his professions who is the people's best friend. And what is true of an individual is also true of parties. On the new Land Act it is not now our intention to pronounce an opinion. But it does seem strange that the quantity of land which can be disposed of annually on deferred payments should be limited to 30,000 acres; and that purchasers should be compelled to settle in certain localities, no matter whether these suited their health, business, or other associations. When these things are coupled with a statement made by the author of this law in the House of Representatives—viz., "We want the land for our children,"—one naturally asks himself, Is this man, is his party, really desirous of placing a large population on the land? or is he and his party only throwing dust in the eyes of the simple? Be this as it may, whilst the patriots eyes of the simple? Be this as it may, whilst the patriots are squabbling over land laws, men with capital are leaving the Province and purchasing land elsewhere. Let the electors look to these things.

CANDIDATES' ADDRESSES AND THE EDUCA-TION QUESTION.

CANDIDATES for seats in the Provincial Council are numerous, and almost all have either published addresses, or made speeches explanatory of their views. A few only have even touched the question of Education, and fewer still have said a word in favour of justice to Catholics on

this most important subject.

Our Provincial education ordinance imposes on teachers the obligation of giving religious instruction to all children unless their parents object. provision of the law, teachers-Taking advantage of this we do not say all—insist on giving religious instruction to Catholic children even after their parents had objected. This, of course, has been denied, but notwithstanding the denial, we assert most positively that such has been the case, and we entertain not the slightest doubt that such will be the case again and again. Some time ago there were published in this paper two letters on this subject, making specific charges of undue interference with the religion of Catholic children. These charges were also made in the presence of the Inspector, from whom the Bishop received a letter a short time ago, stating that an investigation had taken place, and that the charge made was true.

But observe, what was the result. Was the teacher reprimanded—was he removed? Nothing of the sort. On the contrary, an excuse was made for him: He had been lately appointed, and a copy of the new minutes of the Board had not been sent him. For these reasons, therefore, the Board thought he was not censurable for insisting on teaching Protestantism to Catholic children in defiance of their father's remonstrance.

Is such a man as this teacher fit to be entrusted with the education of Catholic children? Is a man whose ideas of religious liberty and propriety are such as to induce him to insult and defy a Catholic parent, a fit and proper person to be master in a mixed school? Can such a man be trusted in the future? Clearly not; and our conviction is there more expeditiously without the aid of these learned gentle- are many such masters and mistresses in the Otago schools

Of this there is abundant evidence that satisfied our minds, but owing to a variety of circumstances it is difficult to bring forward such evidence as will satisfy the Board as to a violation of the law. When, however, it has been proved that the law has been broken, and the religion of Catholic children interfered with, the matter is made little of, and some shuffling excuse is thought ample satisfaction for us.

Only a few of the candidates have expressed the least desire to see justice done in this matter—or evinced a determination even so much as to look into our charges and With few exceptions they have utterly and absolutely ignored us, and are therefore undeserving of

the least support from Catholics.

Since writing the above, we have read the speech delivered by Mr Leary in Caversham; and we feel bound to say that he appears to entertain reasonable views on the education question. He is disposed to do justice to denominations in large communities, such as Dunedin. if this is not all we seek, it is a step in the right direction. The denominations are aware they cannot expect, for some time at least, all they desire; and it is not improbable they may come to the conclusion that half a loaf is better than no bread. Certainly, the Catholic community is not opposed to any compromise that is consistent with their prin-None are more anxious to work harmoniously and energetically with the Government and their fellow-citizens than Roman Catholics. Let them not be called upon to sacrifice their principles and consciences; let justice be done them; and it will be soon seen that they can be dealt with both easily and satisfactorily. The Government would soon find in them energetic auxiliaries in the great work of educating the masses. We can assure our fellow citizens that it is their greatest happiness to be permitted to bear their share of all the burdens inseparable from such an undertaking.

THE IMPROVEMENT OF THE TOWN BELT. MR COUNCILLOR WALTER proposes to expend £5,000 on the Town Belt, in order to render it a fitting place of re-creation. The worthy Councillor deserves the thanks of the citizens, and it is to be hoped the City Council will adopt his wise proposition.

There is one matter having more or less connection with this subject, which we take the liberty of suggesting to Mr Walter as an improvement on his idea. There are two cemeteries, the one to the north the other to the south of this city, and so close to it, as to be a menace to the health of the inhabitants; in fact they may be said to be within the city. This should not be, and it has always appeared to us an extraordinary thing that the North Cemetery should have been ever opened.

These cemeteries should be closed and beautifully planted with shrubs and flowers, and one general cemetery opened either in the Peninsula between Anderson's Bay and the sea, or somewhere in the neighbourhood of Green Island. The latter place, as being near a railway station, would be very suitable; arrangements could be made, as in London,

for a funeral train once each day.

Perhaps Mr. Walter, who is both a humane and practical gentleman, would think this suggestion worthy of serious consideration, and embody it in his project for the improvement of the recreation ground belonging to the Any improvement that can be made will be very incomplete indeed, so long as these two cemeteries remain as they are.

The chief point in the case is that the Education Act is ultravires, as creating summarily recoverable debts of upwards of L20.—A large public meeting has been held at Poverty Bay for the purpose of forming a company to lease the land on which the oil springs are situated, and the area of which is 5344 acres, the leaseholders to receive 1000 shares, and 15 per cent. as a rayalty. This line would develop the timber trade, for which £50,000 a year now left the Province. The want of labor was much felt, but he had received assurances from the General Government that 750 immigrants would arrive by the end of the year. He intends to establish a sheep and cattle station there, to supply whalers, and will also carry on scaling.—

That eighty are let is in the very heart and centre of that opulent city of 300,000 inhabitants. Had he kept that piece of property he might have counted his wealth by tens of millions. While he was running out the sands of life in poverty in the Shasta county hospital, the census of 1872, shows that tract of land which he once bought and sold for \$200 represented more wealth than all the broad acres of California from the mouth of Feather River to the Oregon line. We have rights to guard and privileges to maintain, socially, politically, and religiously; but, whilst we legally and constitutionally endeavour to compass this contributions, we shall never attempt to interfere with the rights and privileges of others. Civil and religious liberty shall be our motto. and when we simply ask this for ourselves, we shall at all times be prepared to freely accord it to all who differ from us in politics and religion. We seek to quarrel wit in one; and will endeavour, if permitted, to pursue the even tenor of our way without giving offence to any; but, if a quarrel should he attempted to be put upon us, we shall went it heldly and feedlessly with restrict to be put upon us, we shall meet it boldly and fearlessly, with merely the simple weapons of truth

and justice, which will prove, in the end, to be a shield and armour of and justice, which will prove, in the end, to be a shield and armour of invincibility. The next great consideration for the Catholics of this colony is, are they fairly represented in the General Assembly? If the number and importance of the Catholic body of New Zealand be taken into consideration, the wonder is, how few of them have seats in the Parliament of the country. Why this should be so I cannot say, otherwise than by remarking that either Catholics themselves are too indifferent upon so important a matter, or that too much intolerance and bigotry is exercised towards them, which ong to not to be the case, when the fact is taken into account that they bear their fair share, in every way, of the burdens of the country, with every other denominaevery way, of the burdens of the country, with every other denomina-tion of their fellow colonists. Why, then, should a spirit of exclusive-ness of this kind be exercised towards them? Yet, in such matters, it ness of this kind be exercised towards them? Yet, in such matters, it is to be deplored that the Government of the Colony would descend from its dignity by taking the lead in this spirit of exclusiveness, not only regarding immigration; but also in its nominations and appointments.

Regarding immigration, the Government appears to be actuated by a spirit similar to that by which the Orangemen of Bandon were moved, when they inscribed over its gates, "Jew, Turk, or Athiest may enter here, but no Papist." The institutions of the Colony, are, more or less, of a democratic character, and, as such, its Government should rule without favour or affection. Encouragement would be given to Chinese, Scandinavian, and any other system of immigration into this colony; but no encouragement whatever would be given to the immigration of Irish Roman Catholics. Ought such an intolerant spirit as as this exist? Decidedly not, especially when it is well known that they are proved to be good, profitable, and loyal subjects wherever they exist.

They are called upon to contribute towards its support, but they are not permitted to have any control in its manag ment. Is this right or just? The principle of "Do unto others as you would wish others to do unto you" is entirely ignored regarding Catholics. If Protestants would not send their children to Catholic schools, why should they expect that Catholics would send their children to Protestant schools? The Catholic Church will never consent to send its youth to be caucated in Godless colleges. This has been the great bone of contention in Ireland: the Catholic Heirarchy of that country, on the one part, insisting upon Catholic Heirarchy of that country, on the one part, insisting upon their right to have the entire control over the religious ducation of the Catholic youth in the schools and colleges there; and the Government, on the other part, sanctioning a secular education only. If any argument were needed on my part to point out the importance of the religious element forming a portion of the education of youth, I need merely direct attention to the schools of the Christian Brothers in Iremerely direct attention to the schools of the Christian Brothers in Ireland, wherein the moral and religious training of the pupils is carefully attended to by those most exemplary men. I have myself known Protestant employers and merchants take pupils from these schools for their establishments as employées in preference to those of their own creed; and the reason is obvious, and requires no xplanation. I wish we had those schools established in New Zealand, and I trust the day is not far distant when such will be an established fact.

I have no doubt at all upon my mind but that the establishment of the New Zealand Tablet will be a great success, not only in Dunedin, but also in every other part of the Colony. A movement is already set on foot in Auckland towards this end. It behoves every Catholic who

WENDELL PHILLIPS ON O'CONNELL.

We give an abridgment of the famous lecture on O'Counell, by Amsrica's greatest orator, Wendell Phillips. It was delivered lately in New York. Whoever has heard this lecture has declared it to be the grandest tribute to the genius, and the noblest culogium of the motives of O'Conn Il that has ever been delivered. We specially commend it to readers of Froude's writings, and of Goldwin Smith, in the contem.

Ladies and Gentlemen,—I am to talk to you of O'Connell—Daniel O'Connell, the champion of Irish Catholic citizenship, and the great example of modern agitation. I originally chose O'Connell as the subject of a Lyceum lecture because he represented, better than any other man of the century, this modern element in constitutional government
—Agitation. You know Sir Robert Peel defined agitation to be tree -Agitation. You know Sir Robert Feet defined agreement of the conscience of a nation to mould its laws, and appeal to the thought and the principle of a community to reach indirectly its ballot-bearing classes."

The power, the reach, the real view and specific machinery of agitation England owes to Daniel O'Connell. He was the first to claborate and profoundly to deepen in the State the exact lines and limitations of the great modern element; he taught the art to Cobden, and if the British people owe anything to Cobden for having lifted the bread tax from the loaves of Great Britain, he learned his lesson at the fect of the great Irish orator.

the great Irish orator.

And another thing that still further emphasizes his claim to represent this element is the question—Who did the most with the least means? Measuring what he had in his hands with the result he produced, he is the most noticeable of all men that ever appealed to this element. And in this measurement few men even stand near him.

Every laurel woven to-day over the brow of Gladstone in his treatment of the Irish—and which must be his largest claim to the gratitude of Great Britain and the admiration of the English-speaking races—every laurel that is woven for his brow might be fairly said to be borrowed from the fame and worth of the great Irish champion.

And it is by no means true that O'Connell confined himself to the simple remedy of repeal or Catholic emancipation. Education and the

simple remedy of repeal or Catholic emancipation. Education and the remodelling of the tenure of land, and the disestablishment of the Church, the removal of that chronic oppression, arising from the company of the control of the church, the removal of that chronic oppression, arising from the control of the church of the control of the church of the parative weakness and strength of the two religious establishments of Ireland. All these three questions O'Connell laid down in his speeches in defiance of the public sentiment of that hour—which ridicaled, despised and hated the very suggestions that, carried into proper support by the experience of half a century and the official influence of the British Premier, are the claim of Great Britain to-day to the sympathy of

I have another interest in the career of O'Connell. Some men wonder why the English scholar, who has just left you, should have brought to America a question of apparently so little interest as the relations of Ireland, but it would be only the superficial thinker that would be let into that mistake. I do not wonder. The relations of Ireland relations of Ireland, but it would be only the superficial thinker that would be let into that mistake. I do not wonder. The relations of Ireland are the greatest and important feature of English political life. Every thoughtful Englishman knows that England to-day is occupying but a second rate place on the cheseboard of Europe; that she has gradually sunk from the position of a first class power. Eig t years ago I was accond rate power on the chese board of Europe, but to-day her journalists have ceased to deny the fact, and are scarching around for an explanation of its necessity. Of the two great causes which have made her fall from her position as a first class power in Europe, the first is the oppression of her own masses, and the second the seven centuries of unadulterated and infamous oppression of Ireland. Mr. Froude told us with an epigramatic force the great truth that the wickedness of nations is always punished. No matter how long Providence waits, in the end the wickedness of a race is answered by the wickedness of their descendants. England has held for seven centuries to the lips of her sister Ireland a poisoned chalice. Its ingredients were the drepest contempt and the most unmeasured oppression; injustice such as the world hardly ever saw before. And, as Mr. Froude said, Providence is holding back that same cup to the lips of the mot er country. The occasions have heen frequent within the last few years when England longed to draw the sword, when the England of Lord Chatham would have flung herself madly into the great military struggles of the Continent. When Germany brought under its heel in contempt the little kingdom of Denmark, that gave Great Britain the Princess of Wales, England longed to draw the sword. When within Chatham would have flung herself madly into the great military struggles of the Continent. Mr Froude could make out that proposition and convince t e world, through the American people, that England accepted the inevitable fate which the geographical proximity of Ireland had entailed upon her, he would have gone far to rub out the celipse of his country's shame. I don't wonder that he should make the attempt. But I believe that, instead of England's having conquered Ireland, that in the true statement of the case, as it stands to-day, Ireland has conquered Mingland. She has summoned her before the power of the civilized world to judge of the justice of her legislation. She has checkmated her as a power on the chess-board of Europe. She has monopolized the attention of her statesmen. She has made her own island the pivot upon which the destiny of England turns. And her last great statesman, the present Prime Minister, Gladstone, ower whatever fame he has to the supposition that he has devised a way by which he can conciliate Ireland and save his own country.

Harriet Martineau, who has found something to explain and something to excuse in every equivocal act of every British statesman; who, however, great her prejudices, has never run along the whole history of a representative Englishman without usually finding half-a-dozen occasions to praise him—in her whole history of O'Connell has never failed to find constant reason to blame him either for a bad act, or, if compelled to acknowledge the act was good, she is sure to search and find a bad motive. He is the only man in the whole gallery of the thirty years' peace of which this can be said, and yet in closing the roll which bears the nam of O'Connell, she is obliged to confess that there is no British subject who has ever misen, in our day, to such a lovel of is no British subject who has ever risen, in our day, to such a level of influence and authority by the sole power of intellect and purpose as Daniel O'Connell.

Having given a summary of Ireland's history of seven centuries, and a vivid picture of the oppressed state of Ireland when O'Connell cntered upon public life, he proceeded :

O'Council began his career by notifying the public that if nine men could neet him in a certain room in a Dublin Hotel at three o'clock on a certain da, he would commence agitation for the repeal of Catholic disabilities. When the hour came only seven men were in the room. O'Conn il waited until four, but no more joined them. Going down to the struct, he caught two young priests by the shoulder, asked them

into the room, and locked the doors on these nine men. You will think very naturally it was impossible to happen that those ten men met in an upper room of a Dublin hotel—two of them prisoners—reduced the strongest Government in Europe, with the Duke of Wellington at its head, to surrender within twenty years.

He claimed of his people a new effort.

He claimed of his people a new effort. The hierarchy of t'e church disowned him. They said we have seen every attempt I ad always up to the scaffold; we are not willing to risk another effort. The peerage of the island repudiated him. They said, we have struggled and bled for half a dozen centuries; it is better to sit down content. Alone, a young man, without office, without wealth, without renown, he flung himself in front of the people and asked for a new effort, What was the power left him? Simply the people—three or four millions of poverty stricken, broken-hearted peasants, standing on a soil soaked with the blood of their ancestors, cowering under a code of which Brougham said, "that they could not lift their hands without breaking it." What was his constituency? If he had the Press, he could not appeal to them with it, for they could not read; he could not marshall them into a great party, for that was illegal. Co-operation in politics, committees of correspondence, the machinery of agitation, as The hierarchy of the church politics, committees of correspondence, the machinery of agitation, as we have it, was illegal. He began his agitation by making speeches. He said to himself: The hierarchy leave me; the nobles require me; the nobles require me; the wealthy scorn me; the educated distrust me. I will lean on the people." He was the first man, as Canning said, "who summoned a race into exist nee and restored the balance of the world."

race into exist nee and restored the balance of the world."

So O'Connell was the first man in Great Britain to summon a people into existence and check the advances of the oppression of the upper classes. He taught Cobden his method. In a certain sense he moulded the age. When Lincoln said, "I drift: I seek only to know the wishes of the American people;" when Grant went into office, saying, "I have no policy; I stand here to do the will of the American people"—they were both echoes of Daniel O'Connell.

So great is the vitality of that famous comedy that only the year before last it was re-produced by Mrs John Wood, at St. James' Theatre, in London, and ran uninterruptedly, if I remember aright, for nearly three-hundred nights. I shall never forget the beauty and completeness of that performance, and my delight with the rendering of the part of Mr Hardcastle, undertaken and admirably executed by one of our own favorite actors, Mr Mark Smith. THE NATIVE DIFFICULTY.

(An Auckland Contribution,)

The effectual mode of settling the Native difficulty has been permitted to pass away; the only mode of securing and promoting the peace and prosperity of the Colony has been manifestly neglected. If the millions lavished upon an almost profitless war had been spent upon a well digested system of immigration, the Colony would bear a far different aspect to that which it presents at present, and we should not be again, as we are at present, threatened with and obliged to enter into another of those death struggles with an obstinate, but withal a brave race; if the cost of the maintenance of the Native Dedartment, both before and since the last war, had been laid out in the introduction of the right sort of immigrants, and placing as near as possible to Maori settlements, the peace of the country would long since have been secured, and we would now be on the highroad to prosperity. If this were done, the Colony would be occupied by an industrious and thriving yeomanry; we should enjoy the blessings of peace and civilization, and not be compelled to enter into another struggle with the Natives to maintain our supremacy—a strife which it makes one shudder to contemplate. The Maori is not yet conquered. "We have scotched the snake, not killed him." But this mode of settling the Native difficulty did not suit the powers that were, nor does it yet seem to suit the views of the nowers that he. The difficulty of settling the question of the subjugation of the Native race, and making them amenable to law and order is, to our mind, not at all in the manner of doing it, but in knowing how to do it; and, in knowing it, having the inclination and courage to do so. The Maori is shrewd and intellegent, and, depend upon it, when he finds himself surrounded by a power superior to himself in strength and intelligence, he will find it to his interest to quietly settle down to peaceful and industrial pursuits. But a policy has been pursued towards the Natives that is at once degrading and ruinous to both races. This policy must, sooner or later, have an end. It is not for the interest of either European or Maori that it should continue. It is therefore to be hoped that the next session of the General Assembly will not be permitted to pass over without making some effort in settling a question that is notoriously retarding the peace and prosperity of the Colony by preventing capitalists from coming here to establish manufactories and otherwise develope our magnificent resources. The Native Department is looked upon with great suspicion as perpetuating a system fraught with great mischief and injury to the interests of the country, and it is thought if that Department was swept away altogether, the result would be hailed with satisfaction by the colonists; except, indeed, by those who "live, move and have their being" under the shadow of its bountiful fig tree. Another great bone of contention with the Natives is the land question, and, in this regard, New Zealand bears a striking resemblance to poor old Ireland. There, like here, the great obstacle to population and prosperity is the land question. There, like here, land s ton other countries. This is another concurty which will have to be dealt with by the legislature. A system that is fraught with no good to the general interests of the Colony, but, on the contrary, a great amount of mischief, will have to be put a stop to—at all events until there is a general consent on the part of the Natives to sell their lands. The following is the proclamation of Tawhiao on the subject of land selling.

Maori people, but to Europeans also:
"1st. Let there be an end to all leasing and selling of land by the Maori people.

"2nd. Let the Europeans cease tempting the Maori people to sell or lease their lands in all time to come (mutu mutu rawa).
"3rd. In the case of any Maori selling or leasing his lands to Europeans on and after this date, he will be fetched to Te Kuiti."

EPISCOPAL VISIT TO OTAHUHU.

On Sunday, May 11, His Lordship the Right Rev. Dr Croke made his visitation in the parish of Otshuhu. At eleven o'clock, shortly after the arrival of the Bishop, mass was commenced by the Rector of the district, the Rev Father O'Hara. The church was well filled, many persons having come from a considerable distance, from Papakura, Papatoitoi, Mongari, and Pannure. There was also a good number of Protestants, mostly of the Church of England. After communion, his Lordship gave a most practical discourse on prayer, the necessity of hearing mass on all Sundays and holy days of obligation; and the great spiritual advantages to be derived from attending that great and solemn sacrifice with proper attention and devotion. He spoke with great earnestness on the proper training of children, as well under parental care as in the schools; on the necessity of using wholesome correction, to force, if need be, the proper direction of their minds, to respect their parents and superiors, to obey the law of God, to love his holy Church and respect her laws: and thus by training the children to Christian habits, they would be ornaments to the Church, and peaceful, orderly, and useful members of society. He gave a sweeping condemnation to the antichristian secular schools, which would have the tendency of raising up a generation of disorderly youths; for independent of moral and religious restraint, and regardless of the divine law, and, consequently, of the law of the country, they would be controlled only by physical force and the terror of severe laws. Hence the secular system of education offered but a gloomy prospect for the state of the world. He made his discourse still more familiar by citing several striking examples, bearing on these subjects, which fell under his own observation. The extrinsically miraculous characteristics of the gospel preaching cannot be too strongly insisted upon; our forefathers were well acquainted with these things. This century has learned to forget them. It does not think itself quite sure that Jesus Christ ever raised a dead man to life. Innumerable times have we heard the literary men of our day ask, with an ingenious haughtiness, what essential difference exists between the teaching of Socrates and that of the gospel. Hear St. Athanasius answer them: "Where," he says, "is the sage, the revealer, the human philosopher, whose doctrine has worked the miracle of enlightening the world, from the dungeon of the slave even to the throne of the sovereign, and of leaving the impress of its divinity on the face of human society? If Christ was no more than man, how is it that his doctrine did not give way before the authority of the pagan divinities? Were there wanting kings and potentates when Jesus came into the world? The Chaldeans had their learned men and their magi; Egypt and India wanting kings and potentates when Jesus came into the world? The Chaldeans had their learned men and their magi; Egypt and India abounded in them. Where is the king, where is the philosopher, who even in the zenith of his glory, succeeded in rendering his doctrine universal; in snatching the world from the darkness of idolatry? The Greek philosophers have written eloquent pages. Yet, compare the effect of their sublime discourses with the conquests realized by the cross of Jesus Christ. At the death of the philosopher, his doctrine was forgotten; during the lifetime of its author it did not even succeed in triumphing over the attacks and controversies of rival disputants. The Son of God appears—he disdains pompous oratory, he borrows the language of the simple, as he had adopted their; poverty; and, beside his teaching, that of all the philosophers pales. He puts an end to all their systems, he draws to himself the whole universe! Cite for me one philosopher who wrought the conversion of souls, who restored innocence to hearts sullied by debauchery, plucked the sword from the hands of murderers, inspired the most timid dispositions with a superhuman courage? Who has subdued barbarism and transformed the pagan world, if not the belief in Jesus Christ?"

9.—THE GOSPEL IS A PERMANENT MIRACLE. Behold, in reality, the miracle of the gospel. Miracle historic, permanent, visible, palpable. At the time marked out, in the series of ages, for the great advent of the Word made flesh, the tide of humanity was being violently hurried along inte the most brutal excesses of sensuality and abject materialism. Who was it that drove back those floods of barbarity, voluptuousness and blood? When the torrent rushes headlong from the mountains, sweeping away in its impetuous course embankments laboriously constructed, aged trees, houses, even rocks, were a man to present himself in the midst of the dismayed population, and stretching out his hand, command the bounding waters to flow back towards their source; if the liquid avalanche, docile to his voice, were to stop suddenly, as if suspended above the valley, and taking an inverse direction, were to rush back instead of descending; had you witnessed that surprising scene, could all the sophists the the world prevent you from proclaiming the miracle? Would it be needful for you to assemble the learned societies, to consult "a commission composed of physiologists, physicians, chemists, and persons skilled in historical criticism?" Ere you had time to reflect on such puerilities, you would be prostrate on bended kneed. you had time to reflect on such puerilities, you would be prostrate on bended knees, praising the marvel of the Divine bounty. In truth, that miracle, which might have saved some few cottages in truth, that miracle, which might have saved some few cottages in an Alpine valley from destruction, is it to be compared with the one which on a sudden arrested in its victorious flight the highest pagan civilization that ever existed, and thus saved the entire of humanity? That is not sufficient for you, you say. "As an experiment ought to bear a series of trials, as what one has done once he ought to be able to do a second time, and as in the miraculous order there can be no question of easy or difficult, the thaumaturgus should be invited to reproduce his marvellous action in other circumstances. If, at each trial the miracle succeeded, two things would be proved; the first, that supernatural coincidences do occur in the world, the

second, that the power of producing them belong, or is delegated to certain persons. Well, the miracle has been reproduced twenty times, forty times, in other circumstances, it has been multiplied in as many nations as have by turns submitted themselves to the action of the Word made flesh. Why do the sons of the Franks no longer go, as their fathers went, in solemn procession to the Druidical forests to cut down the misletoe bough, and pour out the blood of the vanquished on the stone of Teutates? How is it that the Goths, Alaus, Vandals—that deluge of barbarians—were suddenly changed into a beneficent source from which our Christian civilization had its rise. Ask who it is that at the present hour wreather from the hands of the South Sea Islander his blood extrined transition. changed into a beneficent source from which our Christian civilization had its rise. Ask who it is that at the present hour wrests
from the hands of the South Sea Islander his blood stained trophies,
who teaches the cannibal of Polynesia and of central Africa to
respect the flesh and blood of his vanquished enemies. It is the
Word made flesh, who has accomplished these miracle, who has
renewed them, with a visible perpetuity, and who will repeat them
even to the consummation of ages!

10.—MIRACLE OF THE CONVERSION OF THE PAGAN
WORLD.

After that what signifies your wabeliering degree the source of the consummation of ages!

After that, what signifies your unbelieving dogmatism? You say, with a supercilious disdain: "It is not in the name of such or such philosophy, but on the part of constant experience that we banish the miraculous from the pages of history." We answer: The world was pagan, voluptuousness was a goddess, men worshipped her withwas pagan, voluptuousness was a goddess, men worshipped her without reluctance; vengeance was a duty, they found it sweet; enjoyment was the supreme law, it was freely accepted, the passions were consecrated with altars, incense was not refused to them; the most corrupt instincts of the human heart were deified, sacrifice was offered to them without resistance. Suddenly, a few fishermen from Galilee, without learning, without eloquence, without influence, without power, without human prestige, appear in the midst of this world inebriated with sensuality, they say: Lct voluptuousness, even to its name, be henceforth banished from amongst you, in the cross of Jesus Christ are all your delights to be found. If your enemy strike you on the right cheek, turn to him the left; mortify your body, reduce it to servitude; blessed are the poor, the humble, the merciful; blessed the suffering, blessed the persecuted! Behold their teaching. And the world, disturbed in its ancient possessions, grows incensed against the importunate voices which aim at wresting its cupidity, its pleasures, its remorseless feastings, its endless orgies, its accommodating divinities, its banquets, its riotous songs.

THE SUPERINTENDENTAL ELECTION.

MR MACANDREW'S HUSTINGS SPEECH.

The nomination of candidates for the Superintendency took place on the terrace of Government buildings on the 4th, at noon.

Mr James Brown stepped forward land said: Gentlemen, you are this day called upon to nominate a gentleman to hold the office of Superintendent. I have no hesitation in saying that the person whom I am about to propose for your approval and for that important effice is by far the best man in Otago; —(cheers)—and understanding that Mr Macandrew—(cheers)—is to have opposition on this occasion, you will permit me to urge upon every elector in the Province to come forward and place him at the head of the poll.—(Hear.) I have very much pleasure in proposing Mr James Macandrew as a fit and proper person to hold the office of Superintendent.—(Lond cheers.)

Mr James Black: I have very mu c pleasure in seconding Mr Macandrew's nomination; and in doing so it is unnecessary that I should say one word in addition to what has already been said. Mr Macandrew's abilities as a politician are well known, and I have no doubt the action he has taken during the late crisis will meet with the hearty approval of the majority of the electors in the Province. —(Cheers.)

Mr MACANDREW, who was received with loud cheers, said: Gentlemen, my political opinions and proclivities are so well known, and have so often been before the public, that I deem it unnecessary to parade them on the present occasion.—(Hear.) At the same time, perhaps, I may be allowed to trespass upon your patience for a few minutes, while I refer to and indicate the general direction in which I should endeavor to influence the public policy of the Province. As regards the present political situation, as you are aware, I have very fully and concisely, I may say, entered upon it in the Address, which, together with certain official documents appended thereto, has been very widely circulated.—(Mr Joseph Mackay: "At the Government expense.")—The official documents are circulated at the public expense.—(Mr Mackay: "And the private ones too; that is, your manifesto.")—I say, sir, it is a lie; the private ones are not.—(Cheers, and a Voice: "Bravo, Mac!")—Gentlemen, this is the style of opposition brought against me now. As to the political situation, I think that it is unsame time, perhaps, I may be allowed to tresopposition brought against me now. As to the political situation, I think that it is unnecessary that I should go over it again. I shall therefore state very shortly the direction which I think our public policy ought to take. Well, gentlemen, I should say that no man is worthy of being called a statesman—at all events, a Colonial statesman—unless his great object is, and he uses his influence towards getting a regular accession of industrial population to our shores.—(Hear.) I believe that any statesman is unworthy of the name, unless his aim is the attainment of that object. I believe is the attainment of that object. I believe that this Province is capable of affording comfort, if not affluence, to millions of people —to far more than are likely to be brought into it in our day, or in that of our great-great-grandchildren,—(hear)—and, gentlemen, in order to induce a suitable immigramen, in order to induce a suitable immigration to these shores, we must, I believe, bridge across by means of regular steam communication the 16,000 miles of ocean which divide us from the Mother Country.—(Cheers, and a Voice: "Panama and Frisco.") I will come to that by and by. My attentien, gentlemen, has been directed towards this object for some years past, and I am yery hopeful that within a year plant. I am very hopeful that within a very short time we shall see it successfully accomplished. -(Hear.) I am very happy to say that my urgent representations to the Agent-General urgent representations to the Agent-General some time ago, all but caused the steamship Great Britain to some here direct: and if that arrangement had been carried out, it would have been the precursor of a direct steam line between Liverpool and Otago.—(Cheers.) It, however, fell to the ground.—(A Voice: "It's all bunkum.") Perhaps there are many here today who will recollect there are many here to day who will recollect that I was the humble instrument of connect-ing this Province and the Australian Colonies by steam-(Cheers)-with the advantages

that have resulted from it.—(Renewed applause, and a Voice: "But you were ruined by it.") I do not know whether I shall be arrogating very much to myself, when I claim the paternity of the Panama and San Francisco lines; and should we succed in getting a direct steam line from the United Kingdom, I consider it would be of infinitely more importance than all the others put together.—
(Hear.) And further, if we succeed in that, I shall be disposed to retire on my laurels, and die happy.—(A Voice: "Politically, I mean.") Yes, politically. Another subject to which my earnest attention will be devoted, is the providing of adequate means of education throughout the Province, and to some provision for training suitable teachers. We do not need to be told that in a country like this, where the sovereign—I shall be told I am talking bunkum, by some friends behind -power is in the hands of the people, it is of the utmost importance and consequence that means of education should be brought with in the reach of all—(hear)—and also that the social status of the schoolmaster ought to be elevated above what it now is. I believe that those who engage in the important work of training the intellect and moulding the character of the future men and women of in the category of the highest civil servants.

—(Hear.) And I think they ought to be paid accordingly; and with this view I should be disposed to provide that school districts which may desire to pay their teachers adequate, shall be permitted to do so by means of a local rate, provided always that no such rates shall be levied unless twothirds or three-fourths of the ratepayers desire it.—(Hear.) I believe that, if some proposal such as this is adoped, it will lead to very great emulation amongst the different very great emulation amongst the different districts as to getting high-class teachers; besides, it would offer prizes for the profession which would induce men and women of ability to enter upon the scholastic profession.—(Hear.) Well, gettlemen, I should like to say a few words upon the subject of railways; and seeing that I am trying your railways; and seeing that I am trying your patience in keeping you in the rain, I will promise that I will not detain you long.—
(Cries of "Go on.") Had the late Provincial Council proceeded to the actual business of the country, instead of spending somewhere about a fortnight in discussing the question as to whether or not there shall be two Kings in Brentford,—(loud laughter)—for after all that is I think about the size of it,—(Hear.) I say, had the Council gone on with the practical business of the country, instead of discussing this miserable, wretched question, proposals would have been submitted, which, if approved of, would have had the effect of opening up simultaneously with the railway to Dunedin the line from Mataura to Clutha; and I believe proposals would also have been submitted, which, in the event of the General Assembly not doing so next session, would have resulted in the line between this and Moeraki being undertaken by the Province. In addition to that, definite proposals would have been submitted for the purpose of would have been submitted for one purpose of constructing light railways in various out-lying districts throughout the Province : districts which I believe are capable of affording homesteads for hundreds—thou-sands I may say, of an industrial population, both mining and againstural. Although both mining and agricultural. both mining and agricultural. Allendary, perhaps, not many of you may know these districts, I have travelled over a great deal of the Province, and am well able to form an opinion upon its capabilities. Amongst others, it was intended to construct a light line from Riverton to Orepuki, from Riverton to Otautau, and from Winton to the Nightcaps, to open up the coalfields discovered there. Of course, you will understand that I am now talking to the Province as a whole, for I know what I am saying will go forth to the electors throughout the Province. In addition to those I have enumerated, pro-posals would have been submitted which, if approved of, would have resulted in a light railway up the fertile valley of the Waireka. railway up the tertile valley of the Waireka, which is capable of producing millions of bushels of the finest wheat, to be sent into the markets of the world. In addition to that, proposals would have been made for a light line up the valley of the Waiheno, which, no doubt, would ultimately have found its way into the districts of Mount Ida and Strath Taieri. When we find that in these districts it is absolutely necessary

even now to have metalled roads, I say that no Government that sits here will be worthy to keep its position, unless it strains every effort for the attainment of this end; and if it is found practicable to make light railways into those districts, they are far more economical and much less expensive in maintenance than metalled roads. — (Hear.) These, then, were some of the proposals which These, then, were some of the proposals which the present Government had hoped would have been earried into practical effect before new, if the Provincial Council had just gone on with the business of the country. While upon this subject of railways, I may mention, as you are no doubt all aware, that the General Government have just concluded a contract for the construction of a branch line from Tokomairiro to Lawence. I regard this from Tokomairiro to Lawence. I regard this as an instalment of the line which will be ultimately extended into the heart of the Otago goldfields; and, gentlemen, if elected Superintendent now, as I have no doubt I shall be—(cheers)—and the General Assembly does not make provision for the extension of the line next session, I shall be prepared to submit to the Provincial Council sion of the line next session, I shall be pre-pared to submit to the Provincial Council when it meets—which will be after the sitting of the Assembly—proposals for its extension.—(A Voice: "Where is the money to come from?") We have a large landed estate, and I hold that we cannot do better with it than set it aside for the purpose of rendering it more available and accessible, and enhancing its value ten thousand !fold.—(Hear.) You may rely upon it the success of our railway system depends upon the simultaneous construction of railways throughout the Province, and it of railways throughout the Province, and it of railways throughout the Province, and it is a wise policy to press on in this direction. Although as Superintendent I have no interest in Dunedin more than in any other part of the Province, yet I may be allowed to say that Dunedin, the commercial capital of the Province, is especially interested in pressing on these lines, which more or less will ultimately converge on Dunedin, and I say the sooner the better. A great deal has been said as to the construcgreat deal has been said as to the construc-tion of a Harbor Trust in Dunedin. Well, gentlemen, I confess that had the operations of the dredge for the last few months been carried on as they have been for the previous two or thrse years, I should have been very much inclined to advocate the formation of a Harbor Trust: as it is, since the steam dredge has been handed over to the Harbor Department, which ought to have been done long ago, a great deal more work has been done than before. Responsible Government done than before. Responsible Government took a different view to the present Government on this subject; and had the thing been in the hands of the Harbor Department all along, there would be greater good effected, and in all probability the application for a Harbor Trust would never have been heard of.—(A Voice: "That is all bunkum.") I am prepared to show that within the last three months, during which time the dredge has been under the control of the Habor Dehas been under the control of the Habor De-partment, that it has been doing more work than it has done for the previous year or two.

—(Hear.) There is no doubt whatever that (Hear.) There is no doubt whatever that the period is approaching when some modifications of our Provincial Governments will take place, and so soon as our land revenue departs other means will have to be found to administer not only the harbor, but many administer not only the harbor, but many other publicdepartments throughout the Province; but until then I am inclined to think that the harbor will be administered just as well as it is; at the same time I am perfectly satisfied that it is a wise policy to look forward to a future time and to get an endowment from which to administer without encreaching upon the general revenues of the ment from which to administer without encroaching upon the general revenues of the Province. The proposals which I indicated in my opening address to the late Provincial Council would, I believe, have resulted in from L15,0,0 to L20,000 being realised, which I hope to see handed over to a public trust to administer. If that is done, I should say all Jetty and Barbor Dues ought to be abolished. Although there are some of the objects which I desire to see accomplished. I objects which I desire to see accomplished, I objects which I desire to see accomplished, I need not tell you that there is another body to be elected by you which must go hand-in-hand with me—(laughter and cheers)—or I with it, which is one and the same thing, in order to accomplish any of these objects. What I earnestly wish to impress upon you is this: what on earth is the use of electing a Superintendent to carry out these or any other objects unless you elect a Provin-

cial Council very much upon the same card ? -(Cheers). It is of course unreasonable to suppose that 46 men will be got together suppose that 46 men will be got together who will see every subject in the same light; that is altogether out of the question; and I do not think it is desirable even if it were possible, but I think it is quite possible to get 46 men together, the majority of whom will have brains enough,—(cheers)—if I may say so, to see that the Superintendent elected by the people is as much, if not more so, the embodiment of the sovereignty of the people as the Provincial Council itself,—(hear)—because the one represents the people directly, and the other represents them at second. hand. Some two years ago the majority of the electors of this Province rejected one candidate for the Superintendency, and elected another; whereas the majority of the Provincial Council set aside that election, and said "No, we will not abide by the and said "No, we will not abuse by the decision of the people; we will have our candidate in spite of you." I think it a very foolish course for wise men to have adopted; and I hope, gentlemen, that while the Superintendent and Provincial Council will work hand in hand and indules in that the Superintendent and Provincial Council will work hand in hand, and indulge in that mutual concession which is the very essence of politics, I hope, at the same time that the majority of the members, as I have said before, will have brains enough to see the real position of the case.—(Hear.) Why, gentlemen, what would be thought of the owners of a ship having engaged a master to navigate the ship from Otago to London, via Cape Horn, at the same time getting a ship's company who ship from Utago to London, via Cape Horn, at the same time getting a ship's company who were determined not to take the ship to London, and made up their minds to run her up to the South Pole, via the Cape of Good Hope? Now, two years ago, you elected me to take command of the ship, and I was reason and command sense alike die. at least have some voice in the selection of the officers.—(Hear) I see Mr Stout over there: I do not know what he will say to it. I have no doubt he will tell row that it: I have no doubt he will tell you that there is no analogy between the ship of state and a ship of the sea; I maintain however, that there is a very strict analogy between the two on the present occasion. I have been the two on the present occasion. I have been thrice elected Superintendent of Otago; and I expect to be elected for the fourth time. — (Cheers) Of that there is no doubt what-(Cheers) Of that there is no doubt what-ever; and although the office is not a bed of roses, at the same time it is the highest and most honorable position which you can bestow: it is a position which, if I am returned again, it will be may endeavor to fill more worthily in the future than in the past.—(Cheers.) I again say it is my highest ambition to be enabled to be instrumental in merchinal to be instrumental to be to be instrumental in promoting the interests and in developing the institutions of this country—(hear)—a country which I believe is destined to become a very great country yet. Gentlemen, I might go on to compare our present position with promoting the country with process to present our present position with many so-called kingdoms and states; but, I may say that this Province will compare in proportion, as respects its revenue, commerce, and general resources, and is quite equal to several British Colonies—(hear)—and the man who is Super-intendent—the elected head of this Province is of far greater importance than many of the petty princes and potentates of Europe.
—(Loud cheers.)

Mr J. SEPH MACKAY handed in a written

question.

Mr MACANDREW: There is a question that has been put into my hands, and it is this: "What price did Mr James Macandrew pay for the insertion of his electoral address in the Gazette?" Well, gentlemen, I may say that—(Cries of "Oh," and "Don't answer") it is a perfectly fair cuestion. that—(Cries of "Uh," and "Don't answer")—it is a perfectly fair question—the bill has not yet come in.—(Laughter.) I told Mr Dick, the printer, in the presence of my clerk to make out a separate bill for my Address and send it into me. I hope I will manage to pay it when it does come in.—(Laughter, and a voice: "That will do you, Mackay.")

Mr Mackay : Will you circulate and let the address of your opponent be posted in the same way? Mr MACANDREW: I should say decidedly not; but he can arrange with the printer if

Mr Walter: Will you take steps to ascertain whether the statement made in last Saturday's Tablet is correct or not?

Mr Macandrew: I have already taken the necessary steps to ascertain whether the statement of that paper that a free passage had been refused to Otago, because the applicant was a Roman Catholic, is correct or not. I have already prepared a letter to the Home Agent on the subject, and I am under the belief that the statement has not the slightest foundation. It will be recollected that a similar statement was made some two years ago, in regard to which I corresponded with the Home Agent with a like result. Catholics come here as freely as members of any other religion; and I may say that for some years nearly all the men who have been in my employment are Roman Catholics, and men who have come out as assisted passengers.

Mr James Anderson: Seeing that the Province is in such a prosperous condition, would you favor the Civil servants partiei-

pating in that prosperity?

Mr Macandrew: I presume Mr Anderson refers to the reductions of salary that took place two years age. The Estimates framed by the Government for presentation to the late Council centemplated a step in that

direction.—(Cheers.)

Mr SLESINGER: Will you be prepared to support an amendment of the electoral law to provide that candidates shall deposit a certain sum to be forfeited to the State, if the candidate does not poll a certain number

of votes?

Mr MACANDREW: I am given to understand that it is intended to introduce a measure in this direction at the next session of the Assembly, and of course I shall support it. -(Cheers.)

MR M'LEAN AT OAMARU.

Mr John M'Lean addressed the Camaru electors on Saturday evening, and is reported in the North Otago Times to have said that he would give the names of the celebrated Waste Land Board Mr Reid was supposed Allan, James Shaud, Mr Lumsden, and Mr Reid himself. He only gave them the statement as he found it. Now, he respected these men as much as any in the Colony, but there was not one of them, with the excep-tion of Mr Reid, who was able to understand tion of Mr Reid, who was able to understand the most simple Act,—(laughter)—let alone the most complicated Act that had ever passed through the Colonial Legislature. The great card played by Mr Reid was the cry that the Superintendent had exceeded his powers. Why, the very terms of the Act were that the Superintendent should have the power to nominate an Erg. Act were that the Superintendent should have the power to nominate an Executive, who should hold office during his pleasure. He now came to the closing scene. Each knew his part, and the Speaker knew how to act his, and did act it very well. The whole thing was well arranged in order that Mr Reidshould have the last say. The Provincial Secretary having sat down, the Clerk opening a Message from the Superintendent, put it into the Speaker's hand. The Speaker of course was obliged to announce it, and, after some discussion, a second Message arrived, with the prorogation enclosed. The clerk handed this also to the speaker, but the latter nevertheless allowed the member for the Taieri, Mr Reid, to have his fling. the Taieri, Mr Reid, to have his fling. Of course Mr Reid couldn't be thrown back. Others were ready and anxious to reply. When Mr Reid wanted to speak, the Superintendent's communication was "a letter"; when Mr Fish would speak, it was "a Message." He (Mr M'Lean) wanted to speak, but got no chance. The moment Mr Reid had finished, the Speaker read the Message proroguing the Council, and darted out of the chair for all the world like a shag diving off a rock.—(Laughter.) Mr M'Lean diving off a rock.—(Laughter.) Mr M'Lean added—"1 spoke to him about it, and he said 'We were playing chess—the move was mine, and I made it." We know our Speaker, and respect him accordingly. They would see by his Honor's address that it was pro-posed to establish a Branch Lunatic Asylum

at Tomaririro, in which probably the present

Speaker would find a position which would better suit him than that of President of a deliberative assembly."—Laughter, apof a deliberative assembly."—Laughter, applause, and hisses.)
It was a singular fact that when, in after events, Mr Reid formed a new Executive, not one of those gentlemen who had been members of the Government which he said commanded the confidence of the country did here. fidence of the country did he ask to join him. Let him (Mr M'Lean) also tell them how far Mr Reid himself possessed the confidence of the country: why, the very parties who helped him (Mr Reid) to carry his potting on a previous exercise. motion on a previous occasion, were the parties who opposed him this session. were only two defined parties in the House— the Party of Order numbering some eighteen or nineteen members, the party of which Mr Keid was the head numbering about the same, and some eight or ten unattached : so many Micawbers waiting for something to turn up.—(Laughter.) Under such circumstances it was impossible to carry on the business of the country. The situation was perfectly hopeless. Not long after the business of the country. Not long after the time at which Mr Reid saw great cause why he should not resign, the Stafford Ministry went out of office, and he, Mr Reid, was asked to resume his old positions. Why did he not do so? The reasons he had alleged, if they were good reasons, existed still, for up to that time not one member of the Waste Land Board had been appointed. Mr Reid spoke of the great Proappointed. Mr Reid spoke of the great Pro-vincial interests at stake, and said he wished to put a cope-stone upon his work in securing the proper administration of the land law. Well, the opportunity was offered to him, and he refused it. And why? Because he allowed personal feeling to outweigh his public duty. It seemed to him (Mr M'Lean) that in refusing the Superintendent's office Mr Reid must have said to himself, "I know I shall get into my old position are in know I shall get into my old position again, and have the satisfaction of stepping ever your neck." When he got down among his your neck." When he got down among his own people again, numbers were asked to sign a round robin to get him a position which he Mr Reid had refused to accept when it was offered him. Talk of constitutional principles after this! Who ever heard of members of Parliament signing a round robin to the Queen to call Parliament togegether; and if such a thing were done was it likely that the Queen would accede? The thing was absurd, and it was equally absurd to expect the Superintendent to convene the Council merely for the sake of allowing Mr. Council merely for the sake of allowing Mr Reid to be put in a position to oppose him. It was for the meeting to judge how far his (Mr M'Lean's) conduct had been right in the matter; but he confessed he was one of a number of members who held that they had nothing whatever to do with the personal quarrels of Mr Reid and the Superintendent, quarrels of Mr Reid and the Superintendent, but whose wish and desire was to see the business of the country carried through. But no compromise could be allowed—a Government must be forced upon the Superintendent with whom he could not work, and which could not possibly last one single day. The proposed new Executive had been termed by Mr Bathgate the rainbow Government, consisting of Reid, Green. Government, consisting of Reid, Green, Brown, Stout, and Lumsden.
On one occasion he spoke to Mr Reid, and said: "Let it be our first act to repeal the Executive Ordinance;" but Mr Reid replied: "Oh, no, by no means; the Superintendent must have the power, but he must use it rightly." That was the answer of Mr Reid himself, so that you see, if he were in Mr Macandrew's position, he would like to be able to exercise the same powers.

A vote of confidence was unanimously passed in Mr M'Lean.

A Sydney telegram in the Argus says :-"The owner of the steamer Fidelia, recently wrecked off Port Elizabeth, was a passenger by the Baroda. He had intended insuring the vessel in Melbourne if allowed to land there. He was then in quarantine here until the steamer's loss was known, and therefore had no opportunity of effecting an insurance." We are authorised to state that there is no foundation for this statement, the vessel having been heavily insured in London.
