He said that he was a stauncher Home Ruler now than when he landed in the colonies 54 years ago, and as he felt that the present time was the time to act, he asked the chairman to put his name down at the head of a subscription list for 250 as his contribution towards the Home Rule fund. The effect of this announcement acted like magic on the meeting, and Mr. M. F. Bourke immediately offered 20 guineas towards the fund, followed by Mr. John Higgins with 15 guineas. ## Destructive Fire in Wellington

The most destructive fire that has ever taken place in Wellington occurred at an early hour on Monday morning. The outbreak, which originated in a one-storey wooden building situated on Lambton Quay, spread with great rapidity, owing to the shortage of water through the main supply pipe bursting. In less than two hours two banks, two hotels, two insurance establishments, and several business premises were destroyed. Over 100 firms were affected by the conflagration, whilst the damage is estimated at £100,000. The insurance on premises and stock destroyed is over £80,000. The following is a list of the destroyed premises:—Hallenstein's auction mart; Miss Roach's fruit shop; Pinnock's Trocadero (private hotel);—O'Dwyer's Commercial Hotel; Coban's fancy goods bazaar; Levi's optician establishment; Shield's tailoring shop; Whitcombe and Tombs's printing establishment; Bank of New South Wales; Union Bank of Australia; Castendyke and Focke's warehouse; Worger's Strand Cafe; the Alliance Insurance buildings; the Wellington Trust and Loan buildings; the New Zealand Insurance buildings; A. T. Bates's premises. most destructive fire that has ever taken place

The estimated value of the buildings destroyed is £100,000, the chief values being—Bank of New South Wales, £40,000; Whitcombe and Tombs, £8000; the Trocadero, £8000; New Zealand Insurance Company, £2000; Commercial Hotel, £2000. The others ranged from £750 to £1000. Holiday Bros. own the premises in which the fire occurred and also Mrs. Roach's. Hamilton Gilmer owned the Trocadero, the Commercial Hotel, and Levi's. Whitcombe and Tombs, the Bank of New South Wales, and the Union Bank owned their premises, and the latter owned the Strand Cale (occupied by F. Dakin). Mrs. W. B. Rhodes owned the Wellington Trust and Loan's, C. M. Banks's (stationer), and Bates's premises, also those of Focke. The Alliance Assurance Company own their premises and those occupied by Wilson. All the buildings destroyed, with the exception of the Bank of New South Wales, the Trocadero, and Whitcombe and Tombs, were old wooden structures and old landmarks. The Central Hotel, opposite the Bank of New South Wales, had a hole burned in the roof, and many incipient fires from sparks were reported. Several houses on the terrace overlooking the scene of the disaster narrowly escaped. South:

Some £884,025 is to be devoted to railways, and £50,000 is set down for the Otago Central Railway, £20,000 for the Lawrence-Roxburgh line, and £20,000 for the Catlins-Waimahaka line. the Catlins-Waimahaka line.

The Speaker of the House of Representatives (the Hon. A. R. Guinness) has given notice to ask the Premier whether he will, before the session concludes, propose a motion for an address to be presented to his Majesty the King in similar terms to the address adopted by the House of Representatives of the Commonwealth of Australia urging that Home Rule should be granted to Ireland.

The Premier has received a cablegram from the Postmaster-General of the United States announcing that New Zealand letters prepaid 1d would be delivered in the United States without surcharge after November 1. Sir Joseph Ward, on making this known in the House of Representatives, said that he had replied thanking the Postmaster-General, and congratulating him on the establishment of penny postage between the United States and New Zealand. He hoped the day would soon arrive when penny postage would be established throughout the world.
