THE MAORI



IKE Dryden's hind, the Maori, though doomed to death, seems fated not to die. According to the current 'New Zealand Year-Book (just published) the long-sustained decay of our splendid race, that went dolefully on till-1896, has apparently been arrested. For the second time the census marks an increase in the brown men's ranks. To some extent

hope may here tell a flattering tale—a percentage of the apparent numerical increase may, for instance, be possibly due to the diminution or disappearance of the distrust with which many Maoris long regarded the census-taker. But even when allowance has been made for this, the census-paper increase of the Native race from 39,854 in 1896 to 43,143 in 1901, and to 47,731 in 1906 affords a solid ground for the hope that this ancient and interesting people is being rescued from the decay that seems to fail like a blight-upon aboriginal tribes when they come into contact with modern - non-Catholic civilisation.

In the days before the white man settled upon these islands, the Maori race seems to have been far more numerous than at the present time. Judge Maning, of the Native Lands Court, had quite exceptional opportunities of securing information on this subject. The natives,' says he in 'Old New Zealand,' 'are unanimous in affirming that they were much more numerous in former times than they are now, and I am convinced that such was the case, for many reasons.' The evidence on which Maning and others base this judgment may be briefly stated as follows: The great number of deserted pas or hill-forts that are scattered over a great area of the North Island. 'From the top of one of these pointed, trenched, and terraced hills,' says he, 'I have counted twenty others, all of equally large dimensions, and all within a distance, in every direction, of fifteen twenty miles; and native tradition affirms that each of these hills was the stronghold of a separate "hapu", or clan, bearing its distinctive name'. Many of these forts were erected on so extensive a scale that they must have taken a large local population to construct them within a reasonable time with the stone and bone and wooden tools of the old Maori days. For when those weed-grown, hill-top villages were erected, iron was unknown to the Native race, and there was not so much as a tinned tack in all New Zealand. Many these forts', says Travers in his 'Te Rauparaha', were of such an extent that-taking into consideration the system of attack and defence necessarily used before the introduction of fire arms—they would have been utterly untenable unless held by at least ten.
