and the Radical-Socialist 'bloc' or Tammany. French Tammany has at one blow deprived the par-ochial clergy of their homes, furniture, income, and means of subsistence. They have followed this up (as at Saint Servan) by fining or clapping into pulson any priest convicted of requesting offerings scriptions for las support. Henry VIII., in like manner, seized the patrimony of the clergy and of the poor, sold it, or handed it over to his creatures. The poor were thus at one fell swoop deprived of their means of subsistence. But Henry's laws had all beggars who were not aged or infirm whipped at the cart's tail for their first offence of asking alms. For the second offence the beggar's ears were slit, or bored through with a red-hot iron. If caught a third time, the law-made beggar suffered death as a felon. He was, however, spared the extreme penalty (a very barbarous one in those days) on one condition: provided some 'honest person' having £10 in goods or 40s in land, or some householder approved by the justices, would take the poor fellow into his service for two years, and enter into a bond of £10 (a very large sum in those days) for the good behavior of the condemned man. This law remained in force for sixty years. In the days of Queen Elizabeth it was again passed by both Houses. Modern France has repeated a bit of the history of sixteenth century England. It has also made beggars by Act of Parliament. But it has given the old, infirm, and decrepit mendicants of its creation none of the latitude that was allowed to the same class of unfortunates even under the most blood-thersty royal reign of modern times.

Executive Retained by Auckland—Over six hours were occupied in discussing the proposal to remove the district office from Auckland to Wellington. Almost every delegate in the meeting expressed his views on the subject, most of which were a repetition of the views of those who spoke on Thursday, with the exception that the question of centralisation was more prominent in the too lengthy debate. During the afternacion the delegates had their photographs taken, and just before the adjournment for tea the debate was closed, after which Bro. J. J. Callaghan, Wellington, made a spirited reply in defence of the motion.

Before putting the question to a vote, the president stated the executive had invested in property at Auckland the sum of £6475, and the Government valuation of the same was £13,289, showing that the money was profitably and wisely invested. Scrutineers were appointed, and the name of each branch was called out, the representative in response intimating before the whole meeting how he wished his vote recorded. The president then announced that the district was to be retained by Auckland, the voting being: For removal to Wellington, 18, against 36. The result was received with enthusiastic applause.

A Defeated Motion.—Bro. G. J. Sellars, Christchurch, moved that a further sum not exceeding £20, in addition to the £20 now paid on death of a member, be paid, the sum to be raised by levy on the members. Bro. J. Callaghan seconded. The motion evoked much discussion, the custom of the Druids' Order being frequently quetted. The motion was lost.

The meeting then adjourned until Saturday morning, when a motion, proposed by the Christchurch delegate, Bro. G. J. Sellars, which had for its object the abstention of the District Executive officers from voting on the question of the removal of the district headquarters, was lost on the casting vote of the presidents, branch secretary, and branch tre
