About a year and a half ago Mr. Thomas M'Cormack, a respectable tenant on Mr. Shannon's property at Corbally, near Limerick, was evicted and the farm was subsequently taken. The evicted tenant appealed to the city branch of the United Irish League, and Alderman Joyce, M.P., at a recent meeting strongly condemned the taking of the farm. It was decided, if possible, to effect a settlement with the laudlord, and with this object Alderman Joyce and Alderman O'Mara, on behalf of the League, had an interview with Mr. Vincent Nash, the agent on the property. The result was most satisfactory, Mr. Nash meeting the two gentlemen in a most broad-minded and generous spirit, and a settlement

was arrived at by which Mr. M'Cormack becomes tenant again at £51 15s per annum, his former rent being £92. General satisfaction is expressed at the success which has attended the League's intervention in this dispute.

His Lordship urged the Irish people to improve themselves in technical education, not alone the working classes, but also the well-to-do. Christ had sanctified and dignified labor and no man need be ashamed to work. In cultivating industries it was not desirable to gather the rural population into cities altogether, as that led to physical and mayhap moral decadence. Irish parents should have their children taught trades, and let them afterwards ply their crafts in their own rural homes. Mr. Farrell, M.P., in his address, said that it lay with the Irish people to create a demand for Irish manufacture by insisting always in purchasing on being supplied with home-made goods.

A notable Irish-Canadian priest has passed away at Borrisokane in the person of Dean Flannery, of Windsor, Ontario, one of the ablest and best-known Irish ecclesiastics of his generation. Dean Flannery was originally ordained for the Canadian mission, but his health breaking down he returned to Ireland and entered on priestly work at Nenagh. Returning later to Canada, he has been there for the past 30 years, one of the most distinguished members of the priesthood in the Dominion. As a writer he did splendid service to Catholic interests through the medium of the Catholic Press, winning from the Jesuit College of Georgetown the degree of D.D., as an acknowledgment of his defence of the order from the attacks of sectorian bigots. The Flannery attentions the Order from the attacks of sectarian bigots. Dr. Flannery attended the Irish Race Convention in Dublin in 1896, where he was one of Dublin in 1896, where he was one of its most venerable figures. His eulogium of Mr. Blake on that occasion will be readily remembered by those who heard it. Lately appointed Dean of Windsor (Ontario), Dr. Flannery's health shortly afterwards gave way, and in quest of strength in Ireland he gained but a grave in the land of his fathers.
