On July 12 Mr. Francois Lelievre, the oldest French settler in Bank's Peninsula, died in his 94th year at his residence, Akaroa. In spite of his great age Mr. Lelievre enjoyed excellent health until within a few days of his death. The deceased was a native of Normandy, and after an adventurous career went to sea on board a whaler and arrived in Akaloa in 1837. After a short stay he returned to France and came out again in 1840 in the 'Comte de Paris,' which brought 82 French pioneers to found a settlement on the peninsula. They were granted five-acre sections each by the British Government, and it was in the house built on the section allotted to Mr. Lelievre in 1840 that he passed away, he being the last of those to whom the grant was made. Four sons and three daughters survive him, Mr. Lelievre leaving 105 descendants in all, including many great-grandchildren. The late Mr. Lelievre was a good settler, an excellent neighbor, and highly respected by all who had the privilege of knowing him.—R.I.P.

An old identity of Akaroa, in the person of Mrs Rodrigues, wife of Mrs. Antonio Rodrigues, passed away on July 2, at the age of 73 years. SERIOUS ILLNESS OF THE HOLY **FATHER**

The following is a summary of the principal cable messages received regarding the condition of his Holiness the Pope since our last issue:

On Wednesday of last week Dr. Mazzoni, after applying cocaine, punctured the thorax and extracted 800 grammes of sanguineous fluid from the pleura, which afforded the Pope much relief. It was then considered that his Holiness might possibly live for three days. The Kaiser, on Sunday when praving aboard his vacht, concluded with the words: 'The world needs great and good men. May the Almighty grant the Pope many more years of life.'

On Thursday the news was more reassuring, as we were informed that his Holiness had a fairly quiet night, his pulse being frequent but regular. The evening bulletins, issued on July 10, stated that the Pope's condition was grave, the depression had increased, and the pleuratic liquid was accumulating rapidly. On the same date his Holiness had a long conference with Cardinal Rampolla, and was remarkably lucid. On leaving the Vatican Dr. Mazzoni intimated that the Pope was no worse.

Towards morning the Pope experienced great diffi-culty in breathing, and the discomfort increased the op-pression, and the pulse became weak. An operation was performed by the medical men, who extracted 21b of serohernatic fluid.

According to a message dated Rome, July 11, the Pope was so active that he disregarded the injunction to remain in bed, and often walked without assistance to his armchair, where the doctors generally found himand ordered him to return to bed. Replying to their

remonstrances, he said that he wished to die standing. A bulletin issued on Sunday evening stated that his Holiness spent a fairly quiet day in bed. His Holiness is reported to have remarked to a Cardinal: 'I have heen in great danger, but I feel that it has disappeared.' On Monday his pulse was stronger. He spent a cheerful evening, and the improvement was maintained. A cable message received on Tuesday night stated that his Holiness is becoming weaker and breathing more difficult. He conversed with the Cardinals during the evening with great difficulty, articulating monosyllables, and his memory was less clear. The Pope made a slight rally late in the evening, and conversed with Cardinal Satolli lucidly regarding the Biblical Committee. The Pope had a further relapse at midnight.

His Eminence Cardinal Gibbons, Archbishop of Baltimore, has left for Rome.

From a cable message received by us on Tuesday we learn that his Eminence Cardinal Moran left for the Eternal Citv on Monday.

The following letter from the Right Hon. R. J. Seddon was read in the Sacred Heart Basilica, Wellington, July 12, 1903. Dear Archbishop Redwood.—At this time not only yourself and priests, but the laity of your Church, will be greatly exercised, and your heartfelt sympathy and fervent prayers will be unceasingly offered to the Almighty on behalf of his Holiness, the head of your Church, I had the great honor and pleasure of an audience with him, and in his time of affliction my fervent hope and earnest prayer is that God may give him strength and comfort him in his hour of trial. It may be some solace to you to know that through his Excellency the Governor and Secretary of State our sympathy has been officially extended. It is almost hoping against hope to anticipate recovery, but as a good and faithful servant an everlasting reward will assuredly follow, and his good works will live after him and humanity benefit thereby.—Believe me, dear Archbishop, yours very sincerely.
