### AN OUTSPOKEN CORONER.

The following letter appeared in the "Stratford Evening Post":-

A SOCIAL QUESTION.

"As an outcome of a recent inquest at which he was Acting-Coroner, Mr C. D. Sole has forwarded a letter to the Minister of Internal Affairs, of which the following is a copy: 'The Hon. Minister of Internal Affairs, Wellington. Dear Sir,-At a recent enquiry into the death of an illegitimate child, the jury passed a rider that I should communicate with you in regard to the share of the stigma the father should bear. First: Would it be possible to raise the age of consent to 18 years? Second: Would it be possible to revise the Criminal Code so that "mental defective females" could be classed as under the age of consent? From many years' experience on the Hospital Board, we find feeble-minded females become a victim to the lust of a class of "man," and they bring children into the State that are a constant care and burden to all concerned, and will perpetuate their species unless the law is amended. The "man," as a rule, is received into society, attends social gatherings, and is looked on by some as a fairly decent man-probably a more contemptible blackguard is not in existence-he destroys the moral life of the girl, brings untold sorrow on the parents and relatives, and finally marries some girl, who, in his eyes, must be like Caesar's wife-clean and above suspicion. Would you be prepared in all cases of proved parentage to amend the law so that the child shall be registered in the name of the father and the registration Gazetted, so that the father shall bear his share as well as the

The days are at hand when we want big men to deal with big events, and as a lesson of the War, we want the world made better for the coming generations. See that you men who hold the key to the moral legislation of this country give the women of this country a good chance, and make life better for them. Why should the woman pay every time, and become a social outcast, while the man goes scot free, and is still regarded as a respectable citizen. How refreshing to find a jury intelligent and courageous enough to add a rider to their verdict demanding that a father bear his share of responsibility for the death of his illegitimate child. The Coroner's letter does him much credit, and his ple\_ for justice to the weaker sex is a brave protest against our dual standard of morals. Whenever an illegitimate child dies from neglect (either criminal or careless). then the fact that the father has made ne provision for the birth and care of his child should be taken as evidence that he is an accessory to the neglect, and he should stand beside the mother in the dock.

Public opinion should scorn the coward who begets a child and leaves it to the charity of others, and the law should force such men to shoulder their responsibility as parents. The fact that parents are unwedded should not be allowed to lessen their responsibility to their child, and a man should be forced to train, educate, and provide equally for all his children, whether born in wedlock or not. It has been truly said 'There are no illegitimate parents.' There is no

reason why the father's name should not be registered as well as the It is only just that it mother's. should be so. When our M.P's, discussed this suggestion once it was turned down in the House. This was the style of argument used against it, viz., that it was well known the fathers of many of these children were married men, and it would not be advisable to place their names on registers where their wives might see them and discover their unfaithfulness. one word of protest was made about the mother being pilloried upon the register. Why should the woman pay every time, and the man go scot tree? Well, men have made the laws to suit themselves. When women have seats in our Parliament, they will consider the rights of the child of the first importance, and our laws will not be framed to let evil men ruin girls of 16 and cast them and their children upon the mercy of a cold world.

Would it be possible to raise the age of consent to 18 years? Why not? The law protects the property of every boy and girl until the age of Is person less valuable 21 years than property? Apparently the law thinks so. The W.C.T.U. has always maintained that the person of every youth and maiden should be protected as long as their property, viz., to 21 years. At the same time we would gladly welcome the raising the age of consent to 18 years as a step in the right direction, and believe this would do away with much evil.

Re mental defectives, these girls of weak intellect, the easy prey of any scoundrel, should be protected by the State. All mental and moral degenerates should be kept on farm colonies, where they can live in wholesome, healthy surroundings, and be prevented from reproducing their kind.

Mr Sole is right. We want big men to tackle these questions. Our cities must be made safe for little children, and "nought that defileth" should be allowed to enter there.

Don't let us make a mistake—the dual standard must go. Either we must lift the standard of the man up to that of the woman, or we shall have a lowering of her standard to his.

#### THE SOCIAL EVIL.

### REPRESSION OR EDUCATION?

One of the most vital questions in Britain at the present moment concerns the possible spread of venereal disease among the civil population through the demobilisation of the Certain British Societies, in particular the Association for Moral and Social Hygiene, and the Women's Freedom League, are working hard to ventilate the whole problem, and are holding public and private meetings, to which questions and open discussion follow a short lecture or speech by some person of special experience and knowledge. Miss Picton-Turberville has at more than one such meeting spoken of her recent experiences of the campaign instituted in the United States against commercialised vice. Her account of the wave of enthusiasm which has swept over every State in that vast country almost takes one's breath away. The reform, however, seems open to objections of the gravest kind. Extinction by order of the Red Light districts and the removing of all prostitutes from the streets in every city and township has evidently succeeded in repressing the evil for the present. But what of the future? The measure was purely a war one. The purpose, to make the men. "fit." With their characteristic quick intelligence, the Americans have seen that vice does not pay, therefore as the war was to be won, vice must go.

The method of getting rid of the prostitutes is simple. Streets are patrolled and houses raided by an enormous force, of plain-clothes detectives. If in any case a man acknowledges that he has given money to the woman with whom he has been consorting, she is taken to a place of detention (not a prison), but he goes The moral degradation to scot-free. the man seems not to be thought of. What is done to the prostitutes is not clearly known. Apparently they are detained till they are free from infec-No means seems to be provided by which they can earn a living in any way, though the numbers must be far greater than the existing reformatories can deal with.

It has surprised many womer, in Britain to learn that the examination of prostitutes, which is regarded with such loathing and detestation by them, is the accepted rule in America. Another surprise is to learn that this work of repressing vice is wholly in the hands of men. Women appear to know nothing about it. On the local committees which are appointed to see that the Federal Regulations are carried out, there seem to be no women, except in the case of New York and Chicago, where there is in each case one woman, but she is along among fourteen or fifteen men.

Not a few thinkers in Britain consider that the forcible repression of evil for a material purpose involves a deeper moral degradation than even the vice itself. The wrong done to the soul is worse than the bodily disease. But by others forcible measures are advocated, and it is therefore well that the American solution of the question should be carefully considered and its results watched.

One grand advance has been made in America which we in Britain would do well to copy. I allude to the splendid campaign in the schools against alcohol. It will hardly be believed that temperance propaganda is prohibited in the Governmen: schools of London. As indulgence in alcohol is always the most powerful factor in stimulating sexual immorality, we may hope that on the wise lines of education of the young, America will actually achieve the moral reform which repressive measures can never ensure.

About a year and a half ago, the Provincial Equal Franchise Board of Saskatchewan, Canada, circularised the constituent societies of the British Dominion Women Citizens' Union, regarding a campaign among the women of the Empire. But we have heard nothing more about it, except that one great South African society approved of the idea. Nothing will help more effectually to set such a campaign on foot than for New Zealand women to keep us in Britain and in the other Dominions thoroughly informed of what they are doing.

The current number (February) of the "International Woman Suffrage News" contains a fuller account of the American reforms from the pen of Miss Picton-Turberville herself, giving other features of deep interest.

### THE WORK OF THE GOOD CITI-ZENSHIP DEPARTMENT.

It has often been asked what is the object and special work of the Good Citizenship Department, and there has been a generally felt difficulty in knowing just what should be reported under this department. Every year the same difficulty arises, and the result is that it has never been possible to write an Annual Report which shows clearly what the work has been, on account of the overlapping of the different departments, and the failure to discriminate between the special work of each one. It is easy to understand the reason of this, for when we begin to ask what is the work of the Good Citizenship Department, we find there is hardly anything we can take up which is not connected with our life as citizens, and it becomes exceedingly difficult to lay down definite lines. In this paper I want first to speak of some of the general principles of Good Citizenship, and then to suggest special lines of activity to which these principles should be applied.

The aim and object of this Department, known in America as the Department for Christian Citizenship, is clearly implied in that name; it is to endeavour to bring Christian principle to bear upon everything which pertains to citizen life, to ensure that religion shall not be divorced from our political and civic duties, but that these shall all be guided and controlled by our religious principles. The first principle of Christian life, as it seems to me, whether for the individual or for the community, is the subordination of the part to the whole, of the lower to the higher, which in its highest aspect means the subordination of the human to the Divine. And the second, which is in fact the complement of the first, is that the mainspring of Christian, and therefore of citizen life, is devotion and obedience to the highest These we know or can recognise. principles seem to me to contain the essence of Good Citizenship, and it is only in proportion as we make them the rule of our life that we can lay any claim to be regarded as good citizens.

From these basic principles may be deducted certain practical aspects of citizenship, the carrying out of which in all our social relationships would tend to promote that justice, purity, and righteousness which alone can

make a nation truly great. "Righteousness exalteth a nation." (1) The practical application of the duties of citizenship bears mainly on the externa; regulations-the machinery, we might say-by which all civic matters are managed; one of the first essentials of citizenship is therefore an understanding of the laws and regulations for the ordering of the life of the community, and the effects of their operation, of anything which resul's in injustice or bears hardly on any section of the community, and of the methods which might be adopted for the prevention of such injustice.

(2) Then must follow the endeavour to foster in the public mind a sense of the need of regulating one's own individual life strictly in accordance with the regulations laid down for the ordering of the life of the community. It is only as each individual strives in everything to conform to such regulations, even at the cost of some personal inconvenience, that there can be a balanced, well-ordered civic life, and it is only such individual conformity that gives the right to initiate needed reforms in all such conditions, habits, customs, and general conduct, as are not conducive to the well-being of the whole.

(3) Another most important point which should be a first consideration with all possessing the rights and responsibilities of citizenship is the education of the citizens of the future to secure that the influences surrounding the children, whether at home or at school, are such as are calculated to develop all the good that is in them, and to eliminate all evil tendencies, and that their occupations, whether at work or at play, shall be wholesome, elevating, and health-giving; setting before them, almost unconsciously, high ideals and principles, upon which their after lives will be based and their characters developed in a perfectly natural manner; and recognising the need of right physical conditions in order to ensure right mental and moral development.

Bearing these points in mind, it should not be difficult to trace the lines upon which Good Citizenship work should be carried on, and they may be classified under four headings.

1. Study of the Constitution and Laws of our Dominion, both Parliamentary and Municipal. A general knowledge of National Law is necessary for the proper understanding of Civic Law, though it is the latter we specially need to make a study of for our citizenship work; but the two are closely connected, and cannot be separated. Under this heading should also be included a knowledge of Parliamentary Procedure, Rules of Debate, the conducting of public meetings, and everything connected with the proper conduct of all kinds of classes and study-circles.

This includes 2. Electoral Reform. an understanding of the principles of representation, of the defects of the present methods, and the best way to remedy them; also everything that has to do with the carrying on of an election, the methods of voting, and how they could be improved; and the details of work in preparation for a poll. One point needs to be specially emphasised here, the existence of the two rolls, the Parliamentary and the Municipal, and the distinction between This might almost appear to them. be superfluous, but for the fact that even now many of our women do not know of the existence of the Municipal Roll, and the necessity of seeing that their name is placed upon both rolls in order to ensure the exercise of their full rights as electors; consequently, at every Municipal election, a certain number, who have voted at the last General Election, and therefore imagine they have done all that is necessary, find themselves unable to vote because their name is not on the roll. Specially connected with this also is the question of the representation of women, the importance of women's presence and influence on all local bodies, and the need for women possessing the necessary qualifications and having the time at their disposal, to offer themselves as candidates for all civic positions, not only on school committees and Hospital Boards, but on Education Boards, City Councils, and any other local body on which they feel there is work for them to do. Why should anyone feel that electoral work cannot be looked upon as Christian work; there is nothing in life that is worth doing that cannot be brought into touch with our religious life. is only so far as this is the case that our work is of real value, and it is because women have the power to emphasise this religious touch, that it becomes of such special importance for them to take a part in all matters equally affecting both men and women. But in doing so every care should be taken not to arouse a feeling of antagonism by seeming to advocate a

policy in opposition to that so long adopted by the opposite sex, but simply to bring forward the woman's point of view, working in co-operation and not in opposition.

3. Educational conditions and reforms, including everything that affects the welfare of the children, and also of the teachers; the condition of the schools and the playgrounds, and also of the homes of the children, the moral and physical influences that play upon them and are helping to mould their characters and shape their lives; all these things should be of vital interest to the citizens of the present, as affecting to so large an extent the char. acter of the citizens of the future. There is a wide field of work, and one in which women are specially fitted to take a large share of responsibility, by their intimate knowledge of the needs and requirements of children, and of the conditions most conducive to their free development.

4. Sanitary and hygiene conditions, just so far as these are not provided for or are not taken up by any other department of our Union work. This heading will include such matters as food supplies, pure milk, clean streets, housing reforms, town-planning, public recreation ground, etc., with the careful carrying out of any regulations laid down in reference to these things.

These four headings seem to embrace the special points to which the Citizenship Superintendent should give her attention, and which should be reported upon under this department by the Unions. It is in the fourth class that the difficulty of the overlapping of the different departments is mainly felt, but a little careful discrimination should get over the difficulty. In every Convention number of the "White Ribbon" there is a list of the departments of Union work, and a little book has just been published, price 4d, "A Handy Booklet of the W.C.T.U.," in which the work of each department is outlined. By reference to these it will not be found difficult to decide to which department any particular piece of work belongs and should be reported; anything which does not seem to belong elsewhere should be reported as Good Citizenship work. If Union Secretaries will bear this in mind, it will greatly facilitate the work of the Dominion Superintendents at the end of the year, and will also make it possible to gain a much clearer idea of the work of the Union as a whole.

### INTER-ALLIED WOMEN'S CON FERENCE IN PARIS.

The Inter-Allied Women's Conference in Paris, called by the French Woman Suffrage Societies, of which I wrote last month, was a marked suc-A series of most interesting meetings, attended by delegates from Belgium, Italy, Britain, the British Dominions, and U.S.A., was interspersed by even more interesting interviews with all the chief representatives of the Powers, assembled for the Peace Conference. President Wilson, in particular, gave a warm welcome to the women, and strongly supported their claim that a committee of representative women should be appointed to sit in Paris during the Peace Conference, in order that their advice may be sought in matters specially relating to women and children. Such a committee has now actually been chosen, and is sitting in Paris. Though it is merely an advisory body, and its recommendations have no force or claim to be heard beyond that of courtesy, yet it is a step in advance for women to have secured even so small a share in the momentous decisions on which the fate of the world depends.

The following resolutions were carried unanimously, without discussion, by the Women's Conference:—

That in every one of the Allied countries-

- (a) Women shall be granted the vote on the same terms as it is or may be granted to men.
- (b) Married women shall not be deprived of their nationality against their will.
- (c) All existing inequalities in the law as between men and women shall be removed, all offices and employments shall be open to men and women equally, and payment for work done shall be independent of sex.
- (d) The moral standard shall be equal for both sexes.

These resolutions were sent by the British Dominions Women Citizens' Union, and were moved by the delegate of that Union, Miss Atkinson, of New Zealand, by the request of the French President, Madame Schlumberger. They form, as it were, a Confession of Faith, a programme upon which the leaders in the allied countries are agreed, without discussion.

### W.C.T.U., CAPE PROVINCE.

(To the Editor.)

Dear Editor,-A promise made to the executive of our Cape Province V.C.T.U. constrains me to send you this letter. I was asked to send to your paper a report of the twenty-ninth Convention, which was held in Cape Town during the month of October, 1918. Before the business sessions were over many of the delegates were laid low by the terrible epidemic of Spanish influenza, and in less than a fortnight the dread disease had spread all over the Union. I did not reach my home in Port Elizabeth, a distance of over six hundred miles, for three weeks, owing to the difficulties of travelling, and then found many duties in nursing relatives and friends. So time passed, and I felt that through the columns of our own "White Ribbon" you would have learnt much of the Convention doings, and that it was not necessary to repeat these.

i may just say the Convention was felt by all to be a time of mutual encouragement and blessing, and an education to many of the delegates who attended for the first time. putation appointed to wait upon the Superintendent-General of Education to urge the teaching of Hygiene and Scientific Temperance in schools met with a cordial and sympathetic reception, and a promise that these subjects should be introduced into the teachers' training courses. It was pointed out that unless teachers were qualified to undertake this instruction it would be of little use placing it upon the school Our Parliament, which curriculum. is now sitting, has under discussion the recommendation of the Roath Committee. This Committee was appointed by the Government last year to consider the Transvaal liquor laws. especially in regard to the illicit aquor traffic along the Witwatersrand. The proposal to establish Government canteens, where natives can be served with beer and natural wines of 10 per cent. alcoholic strength, has raised a storm of opposition from all parts of It is hoped that the the country. measure will be thrown out of the House, and it may not come to a vote. It has the strong support of the wine farmers of the western portion of the Province, who are eager for further markets.

The Public Health Bill, which is being debated in Parliament, is also giving great dissatisfaction; protests are being made by many prominent men

and women against certain clauses, which not only involve but extend the principles of Part 1 of the C.D. Act, the repeal of which the W.C.T.U. has for years worked strenuously. A meeting of women's societies has been called by Mrs John Brown, Superintendent of Purity and Moral Education, W.C.T.U., to call the attention of the Ministers and Legislators to these objectionable clauses, and to protest against their inclusion in the Health Act.

The movement for Woman's Suffrage is slowly gaining ground in our Parliament. A Pariamentary Committee, composed of members of all political parties, has been formed in the House, and it is hoped we may see the enfranchisement of women ere Though South Africa seems to be the most backward of all the British Dominions in the matter of liquor reform, still one is cheered to find that a temperance sentiment is growing up The children that used net to exist. being taught in our Junior Branches, and through prize essays in connection with the Scientific Temperance Department, that alcohol is a poison and not a food, they are passing this thought on to their parents, who realise that it is necessary to abstain from intoxicants if they wish to enjoy good health. My husband and I are now on holiday on what some twelve years ago was a large wine and The present owner, on brandy farm. purchasing the property, rooted out 153,000 vines, which covered about 40 acres of ground, replanting it with wheat and lucerne seed, putting in currant and sultana vines, and many kinds of fruit trees, so that a large fruit industry has been built up. The distillery (the building) is now used for the making of vinegar. Ostriches and cattle roam in the lucerne "lands," as they are called here, and prosperity has come to the owner, who has given a practical lesson to his neighbours of good management and good living. It is said, by the way, that the wine farmer seldom grows rich. I fear this letter will be too lengthy for insertion in your paper, if I do not stop! I feel I must say how we rejoice in the prohibition sentiment in New Zealand that has closed all bars at 6 p.m., and I hope that prohibition of the liquor traffic will soon be enforced in your country. greetings to all White Ribbon comrades.-I remain, yours in the cause we hold dear,

### CARE FOR THE CHILDREN.

To every child belongs the right to be well born. In Russia, one baby in every four dies before completing the first year. In the United States, about one baby in ten; that is better than the Russian record. But in New Zealand, only one baby in twenty dies in the first year of its life. This is the result of an educational campaign, the care of the expectant mother, and instruction given her on the care of the little babe.

To every child belongs the right of an education, which will probably equip him for his place in the world. In future years, in all schools, children will be weighed and measured monthly, medical examinations of throat and nose given, hot lunches will be furnished at noon, and both city and country schools will have supervised playgrounds with play leaders and play equipment. The public school must have its big part in child care and adequate compulsory education laws must be passed.—"Exchange."

#### ECHOES OF CONVENTION.

Another Convention has come and gone, and we are on the eve of entering upon another campaign, even if we may not say it has already begun. Meanwhile we may take a short breathing-space, and looking beau over the doings of Convention, there are a few points that it might be worth while to note, for which neither time nor space was available in the Convention number.

One of the necessary det its of work for the next Poll is the instruction of our people in the method of voting on the three-issue ballot paper. A good suggestion made by Miss Henderson was that an election should be held frequently at an ordinary meeting of the Union. It would not be difficult to obtain or prepare a few specimen papers, and a vote could be taken among the members present. The papers should be carefully scrutinised, and with the help of a blackboard, any mistakes or informalities could be explained, and if many such had been made, a second ballot could be held, giving the opportunity for correction.

Some suggestion was made for doing away with the well-known "Strike out the top line." But it seems a pity to throw away the result of so much energy spent during past years in drilling prohibitionists in this simple method of securing, almost automatically, the desired casting of the vote. A slight modification of the familiar line will bring it up-to-date; and "Strike out the two top lines" can be made to fit the same melody by singing the words "two-top" to short notes in place of the one long note for "top," this alvantage also being gained, that the word "two" can have a strong accent put on to it; thus calling attention to the important change in the voting. Apropos of singing, Miss Henderson made a further suggestion that should appeal to all music-lovers, that at the meetings of Unions more use should be made

of campaign songs, set to well-known popular airs.

Several points of interest were brought out in the Ouestion Box. The value of Provincial Conventions was emphasised, as it was also in one of the closing paragraphs of the Corresponding Secretary's report. Every District Union should endeavour to hold a Provincial Convention for the education and benefit of the smaller Branch Unions, which are not always able to send a delegate to the Dominion Convention, or two or more neighbouring District Unions may often combine with mutual advantage. Referring to Unions not being represented at the Dominion Convention, one speaker stated that in some countries it was compulsory for Unions to send a delegate, and Mrs Don expressed the opinion that the travelling expenses of a delegate ought to be regarded as a first charge on the Union's funds, to be met before any money was voted to an outside organisation, however laudable the object of the latter. Every Convention our President speaks in terms of strong disapproval of the action of any Union in voting sums of money from its funds to objects that are outside the activities of the W.C.T.U., when there are so many channels within the Union into which lovalty would prompt that surplus monies should be diverted. On the other hand. Unions that are too poor to afford the delegate's expenses from the ordinary funds, could get up an entertainment for the purpose; this is the method adopted by some. In answer to questions, the President stated that an individual Union has not power to get up a petition without reference to the Dominion Executive; that the President of a Union is justified in refusing to take a resolution she considers ultra vires; that a Union should not get up a presentation without the knowledge or consent of its Executive; and that a Union may ask help from other Unions in the way of funds for an institution run by the W.C.T.U., provided it has

obtained the consent of the Dominion Executive.

Attention of Unions is drawn to the matter brought up in the discussion on Military Camps report, namely, the advisability of getting in touch with the young wives of returned soldiers coming from Home. Several delegates promised to see to this in their own districts, and here is certainly an opportunity for showing a little real sisterly sympathy that will help to make the young brides feel at home in their adopted country.

McCarthy's motion to add Superintendents of Departments to the Dominion Executive was lost chiefly on the ground of its undemocratic character in discriminating between the Departments. The new form given by Mrs Field's notice of motion, that Superintendents who are present at Convention be given a seat on the Executive for that Convention, may possibly appeal to delegates, as it is not open to the same charge. Mrs Peryman's motion re proxies was lost, and immediately handed in again as notice of motion for next year. It was admitted that the time is hardly ripe for it, but its purpose is to a great extent educative, that Unions may be led to realise more fully the necessity for each one being represented directly at the Dominion Convention by a delegate who knows something of the special needs or conditions of the district.

The meaning and origin of the term "Somerset" members was explained at Convention for the benefit of some to whom the term was new. "Somerset" members, or members not attached to ? Branch Union owing to their residing in places where no Union exists, were so named from Lady Henry Somerset, formerly World's President; but it was suggested that a term more readily understood in New Zealand would be "National" members, as their fees are paid direct to the National Trea-

Speaking of liquor licenses on coasting steamers, Mr Peters related a little incident that came under his notice. He was travelling by boat, and happened to hear a young man, also a passenger, ask the steward for a cup of tea for supper. He was informed that tea was not served for supper; and apparently there was nothing available except what could be obtained at the bar, alcoholic beverages or soft drinks. Mr Peters made it his business to inquire and to remonstrate, with the result that the desired cup of tea was soon forthcoming. In how many little ways are young men almost compelled to form the drink habit!

A point made by our Legal and Parliamentary Superintendent was that Unions and members could often materially assist the carrying of reforms if they would adopt a method very common in America, and bombard their M.P. with telegrams when a matter comes up in Parliament for discussion or for voting, that is of special interest to the Unions, particularly if it has been the subject of a resolution forwarded to Cabinet or to Parliament. This is one of the most effective means of influencing members to take a decided stand.

One last word to Unions re the White Ribbon Hymnal. This is such a beautiful little collection of hymns that it is a great pity all our Branches do not use it. But, at least, will those who do use it try to learn some of the beautiful hymns that are not quite so familiar? On one occasion our President wished to have Hymn No. 85 during the Convention, but finding that hardly any of the delegates knew it, she was compelled to change it. Let us see to it that next year this hymn at least shall be known to the majority of delegates present!

Mrs Fulton, one of our oldest members, has just been called home, after a pilgrimage of over 90 years. She was the first President of the Dunedin W.C.T.U., and was afterwards National President. The accompanying sketch was written by her son, Mr C.

A. Fulton:

# Mrs. Jas. Fulton, and the Original W.C.T.U., Dunedin in the Early Seventies.

Mrs Fulton became a teetotaller through hearing a lecture by Mr Jno. Jago at Woodside 1.O.G.T., when forming the "Welcome All' Lodge there. Her sister, Miss Valpy, also took the pledge with others at the same time in the early seventies, and became an ardent worker in the Temperance cause. The visit of Mrs Leavitt led to my mother's appointment as President of the Dunedin W.C. r.U. and her regular visits to the meetings in town through all weathers. Mr Fulton used to say that "the ladies were learning business at these meetings," and he was always ready to help and support the female franchise.

From small beginnings much was developed, and agricultural shows had "temperance tents" run by the W.C.T. U., and the Sailors' Rest was an outcome of their persevering efforts, and support of Mr Falconer's work for the seamen.

Lectures in the city were promoted, and Mrs Fulton became gradually accustomed to preside in public, though against the grain, unless my father was with her on the platform.

Correspondence increased enormously when she was appointed National President for the whole of New Zealand, and she resigned entirely on the death of Mr Fulton in 1891. Since then her interest and prayers have been with the temperance movement, and she went in person to vote in April at Woodside, and was greatly rejoiced at the first results of the poll.

"She rests from her labours and her works do follow her"; and "Her children arise up and call her blessed." —Proverbs 31:28.

### MRS PATTERSON (Christchurch).

We deeply regret to hear of the passing away of Mrs Patterson, Treasurer of the Christchurch Union. She was the mother of the Rev. J. Patterson, of St. Paul's, Christchurch, and was a woman of fine spirit and a devoted worker for church and social reform.

She had been ailing for some time, but the call was sudden at the last.

Retiring in her usual health, she was reading in bed when she complained of feeling unwell, and in less than half an hour "She was not, for God took her."

The Hastings Agent went home from Convention determined to do her best, and in four weeks sent in 11 new the same During subscriptions. period Miss Earnshaw was successful in gaining 14 new subscriber in Hastings and 18 in Napier. So within six weeks of the request being made, Hastings has got 25 new subscribers more than twice its quota of one per month for the year, and Napier, with 18 new subscribers, is well over the quota.

Here is work for quiet workers. Try to get our paper into homes where the education on Temperance and Social Reform is needed. We have distributed much free literature, but people often will read a paper they pay for when literature distributed goes into the waste paper basket.

Don't say it can't be done. Do it. We want a few women of this type in every Union.

### THE DIVINE RICHT OF THE MALE.

At the meeting of the Otago Branch of the Educational Institute, one of the women teachers had the temerity to propose that the salary of infant mistress in large schools should be equal to that of the first male assistant. This natural and modest request called forth a storm of indignation from several of the male teachers. It is a long time since we have heard men argue so decidedly in favour of the divine right of the male to receive an extra salary because he is a male, and not because he earns it.

The old argument (dead as the dodo) was advanced, viz., that men had families to support. Now, if the gentlemen had suggested that teachers should be paid according to the number of their dependants it would at least have been a logical proposition. The Methodist Church recognises this principle, and while their church pay a fixed salary to their ministers, a Church Fund supplements this fixed amount with a bonus of £9 per annum

for every child until it reaches the age of 18 years.

Let the male teachers, if they wish, ask for a bonus to each teacher (male or female) of so much per head for Why should a every dependant. bachelor draw a larger salary than the bachelor girl, who goes through the same training, passes the same examinations, and does the same work as he does? All who know school work from the inside, will admit that the position of infant mistress demands skill, patience, devotion and training at least equal to that required for first male assistant. We don't hesitate to maintain that while many women teachers could do the work of the first male assistant, it would be very difficult to find a male assistant who could manage an infant room with skill and ability. Why then pay our infant mistresses a salary equal to third male assistant? One gentleman waxed indignant at any women, even after years of training, being able to draw the princely salary of a first assistant. He would like these women teachers to go before a Committee of Mothers. So would we! The mothers of this Dominion are not so shortsighted as this gentleman imagines. They know that when their daughters compete in the open labour market, the only just law is "equal pay for equal work."

We quite expect that these male teachers wax eloquent to their pupils over the injustice of the Test and Corporation Act, which debarred all but members of the State Church from serving as officers of State. They see the justice of "no sect in politics," can they not see the equal justice of "no sex in citizenship?" Differentiate salaries on the ground of ability, experience, etc., differentiate if you like for the number of dependants, but in the name of common-sense, don't attempt to differentiate upon the ground of sex.

We believe the highest office in the State (the Throne) pays equal emoluments to a King or a Queen.

We should advise the male teachers to cultivate their sense of humour, and then they will see how ludicrous it is to argue for extra pay, just because they are Men. (Spell it with a capital, Mr Printer.)

### CARRY ON.

(An Address given in Queen's Hall, London, to V.A.D.'s and other workers, by K. J. Saunders, Y.M.C.A. Council.)

There is a striking American poster, which depicts a bright field of poppies dotted thickly with wooden crosses. A girl is standing by one of them, and the words which she seems to hear ringing in her ears are these: "We shall not sleep unless you carry on." This is the theme upon which I am to speak to-night. Let us imagine that we are standing on one of the great battlefields either at Ypres, where 500,000 of our best Englishmen lie buried, or at Verdun, where threequarters of a million of France's noblest and best lie guarding the heights they defended so nobly.

What would be the message that came to us from these great fields of death? Would they not ask us to see that the great task to which they had put their hand was not allowed to remain unfinished, that the great principles for which they died should be established for ever on the earth?

What are these principles except the great principles of what we so strangely call "Foreign Missions?" Let us think of them one by one. There is first the determination to put an end to war, to establish peace and goodwill. Is it not true that these men died that their children and grandchildren might not suffer as they have done? Secondly, the war was a great stirring of the human spirit towards freedom and democracy. They felt it intolerable that any autocratic power should be free to impose its will upon others, however weak and small. It was for international righteousness that they died, and they lie buried in Belgian soil as a great protest that there are no contemptible little nations, and that all have their right to a place in the sun. Then, again, the war was a great and shining example of human service; we are our brother's keepers, and for the joy that is set before us we may well endure the cross, despising the shame like that great leader of the world's youth, who has been called "The Young Prince of Glory." So they died for the sake of those at home, and those abroad-a great victorious army.

Now I think that whilst women are doing their part at home and on the field, many of them, perhaps most of them, longed that they might have the privilege of sharing to the full the suffering, and so, to-day, I think these men would say to us all: "There are these principles still infinitely worth living for, and they are the principles for which we have died. You may yet claim your share in sacrifice."

These are the central principles of what we call "Foreign Missions." May we not say that our men went to France on a great Foreign Mission, to proclaim the principles summed up in the Premier's phrase, "Everybody's World?" The world is one; the only race is the human race. Those who do not believe in Foreign Missions do not really believe in international righteouness, or in the rights of the smaller peoples, or in the great brotherhood of man, or in the essential goodness of human nature. What is far more dangerous, they do not really believe in Christ or in His Church. To those within the Christian fold who would say to us: "The Church has failed at home, why should she throw out her outposts into Asia and Africa?" would reply in the words of that great man of faith and vision, Marshal Foch. In April, when the cause of the Allies seemed lost, they came to him and told him, "Marshal, we cannot hold on." "I cannot hold on," he cried, "then I advance." And so it is with the Christian Church; assailed by a storm of criticism, cursed for not having prevented the war, blamed because she has not spoken with one clear voice during the long years of the world's agony, she replies: cannot hold on, then I advance." It is only in proportion as she has faith to see the world's need as a whole, to do her part in helping the devastated countries and the great needy continents, that she will get the vision and strength to solve her problems at home, and the fire to cleanse our slums and rookeries, of which we are so ashamed to-day. We cannot really set out own house in order unless we have a world wide horizon, and a passion that no race should be left outside the Kingdom of God.

We are realising every day that the world is one world; an opium scandal in a London den reminds us of our guilty past in our relationships with China; we find that what we do 10,000 miles away reaches at the heart of the Empire; a glance at a French town shows us how men have come together from all the ends of the world—white, red, brown, yellow, black men

-from all continents. We see there that the inferior races have been good enough to help us in our hour of need; that tens of thousands of brown men and yellow men, not called by Christ's name, have given their lives for a great Christian principle, and we see dawning the vision of a world unified and made new by the spirit of Christ. Let us think of some of the great needs of the world as they call upon us to come and help them. Think of the women and children of Armenia, for example, where a million have been killed in cold blood. Think of the virile, attractive peoples of Arabia and Mesopotamia. Under Turkish misrule, the population of these lands has dwindled from 11 million to less than a million, and children die like flies. Again, are not Russia and Serbia calling to us to help them? Poor Russia! Or there is the great continent of India, where to-day women are coming into their own, where ambition and the longing for service is stirring in them so that the Women's Colleges, newly started, are full to overflowing. What a call for leadership there is from the women of India, and they ask us in the words of one of their women poets:

"When the terror and tumult of hate shall cease,

And life be refashioned on anvils of peace.

And your love shall offer memorial thanks.

To the comrades who fought in your dauntless ranks:

And you honour the deeds of the deathless ones.

Remember the blood of my martyred sons!"

There is attractive and fascinating work for the young girls of India now open to such movements as that of the Girl Guides. India is to-day rising to new heights, seeing new visions, filled with new longings, asking for new friendships. She has a glorious past; yet she is poverty-stricken and in need. She asks for men and women of the West to come out in no spirit of patronage or of dominance, but as servants and friends. one thinks what women have done under the Red Cross, and realises that only 51 million of India's 300 million people get proper medical attention, one thrills with the thought of a great Expeditionary Force of skilled doctors and nurses from the West going out in the name of the Great

Christ comes and teaches us to think in terms of God, and terms of humanity. This is the only hope so far as I can see."

And as if to prove it, the little Christian Church in China stands firm when all about it is breaking up. As In the great days of the Renaissance of Europe, it is the Church of Christ which shows men how to live, and how to carry on. I think it is fair to say that the patriots of China are saying that the great poet and patriot of India said just lately: "Our lamp has sone out; will not Britain let us light t at hers?" In these great lands the amp of Confucius, the lamp of Budtha, and the lamp of Mahomet are all burning dimly and fitfully, and in spite of all our sins in the West, we have he wonderful asset of the life and leath of Jesus Christ telling us what ood is like, and this is what the world s hungry to know.

Think of Africa, again, with all its dim, child-like peoples, in the grip of lear and suffering unnameable things. Think how one nation after another from the West has gone in and exploited these simple peoples. We

think of the terrible record of the Germans in German South-West Africa. It is not worse than that of our allies, the Belgians, in the Congo,

are without blame in the way we have exploited the weak peoples of Africa. But when they meet with Englishmen, who are also Christians, they show us, as they showed to Livingstone, how magnificent is their loyalty and their child-like faith.

When the body of Captain Selous, that mighty hunter, was lying out in No 'a's Land, two brave men went out to bring it in. One was his African servant, and the other was a young Englishman, and side by side they fought for it, and brought it back. The young Englishman has given us his name as one who aishes to go back immediately as a missionary to that great dark continent, because he realised as in a flash what sterling qualities there are in African hearts, and because he knows that his Master needs the gifts that Africa has to offer.

And so I think we may say that His Kingdom will not be accomplished nor His heart satisfied until He sees the idealism and the spiritual vision of India, the cheery optimism and the practical genius of China, the loyalty and rugged faith of Africa laid at His feet, and made available for the great Commonwealth of Nations. The task offered to you is to help, whether at home or aboad, in building up that great Commonwealth, and the needs of these countries for people of sympathy and vision are clamant to-day; for in China, as in the West, in India, even in Africa, a new world is being born, and Christ is making all things new. Let Him speak to our hearts through the lips of the great dead, His challenge to us to carry on.

They have won the war; it is for us to win the world. Not to dominate, but to serve; so will Britain carry to a worthy end the great word of the past; so will she complete the great struggle for the freedom and democracy and righteousness of the world.

It is not for nothing that the 'nglo-Saxon race controls one-third of the habitable surface of the globe; that it handles half of the world's wealth. It is a great stewardship from God. Let us use it in His Name, and for His Kingdom. And the lives He has given us—shall we not dedicate them in His service.

### THE COLDEN RULE.

Some of the facts stated by a deputation representing the shearers, which waited upon the Minister lately, make interesting though most unsavoury reading. According to their statements, the worst features of Slumdom are to be found on large stations around Gisborne. Where the owners live in palatial residences, the quarters of the shearers are "indescribably filthy, alive with vermin," and in some cases both sexes were sleeping in the one room. Mention was made of at least one station where several married couples were sleeping in the men's dining-room.

The speakers did not ask for luxuries for the men; their demands were for (1) comfortable sleeping quarters; (2) decent sanitary arrangements; (3) facilities for bathing. The big squatters are the chief offenders, smaller farmers as a rule obeyed the law, and provided the common decencies of life. Evidently the Government does not compel the "big man" to comply with the law. Is this fair to the smaller farmers?

Even the most conservative members of our famous National Government will admit that the home is woman's sphere. Why not appoint a few capable women inspectors, and send them round armed with powers to enforce the law, and see that "homes" are provided for the workers on stations.

### AMERICA'S BONE DRY AMEND MENT TO BE TESTED.

The legislature of Rhode Islan has adopted a resolution instruction its Attorney-General to begin action in the name of the state to test th constitutionality of the Eighteent Amendment. So far as is known, a State has ever before asserted it sovereign right against its siste States. The purport of the resolution is that the Prohibition Amendment 8 an infringment upon the police power of the State, hitherto exclusively es ercised by them, and therefore is no an amendment to the Constitution but an infringement of sovereigh rights "contrary to the spirit and sys tem of the dual form of government erected by the Constitution."-"Union Signal."

#### RED RAC TO A BULL.

At a conference of returned soldiers held in Christchurch, the question of V.D. was discussed, and a proposal was made to ask that the C.D. Acts be reintroduced. In the course of the discussion, one speaker remarked that to mention the C.D. Acts to some women was "like showing a red rag to a bull."

We wonder if these gentlemen realise the cause of women's strenuous opposition to these Acts. It may be briefly stated.

(1) They recognise a double standard of morality, and punish one partner in a dual sin.

(2) They practically admit that it is the duty of the State to provide "clean" women for the lust of men. There is no attempt to protect the women by detaining diseased men. The law does not even attempt to save wives from being affected by diseased husbands. It does not try to protect children from the awful heritage of a father's wild oats. All it does is to try to protect men and let ail suffering fall upon the women and children.

(3) It demands a fearful tribute of the nation's girlhood. When women become diseased and are detained fresh girls have to supply their place. These are infected by filthy men, and more are called for, and so the vicious circle goes on. These girls are mostly under eighteen when they are first ruined.

Is it any wonder that the attempt to enforce this vicious system,—to allow beastly, foul men to debauch our girlhood, throw their victims upon the rubbish heap, and demand other girls—would drive the womanhood of this Dominion into open revolt? No Government would dare advance such an unjust and one-sided law.

The only way to stamp out disease is to stop the sin which causes the disease. Public opinion must outlaw the Male as well as the Female prostitute.

### PROHIBITION FACTS.

In 1917, England spent £295,000,000 in liquor. The Commonwealth of Australia spent during the war on liquor £70,000,000. The beer brewed in England in 1917 was equivalent to 268,000,000 loaves of bread, and over 65,000 tons of sugar.
